ORDER

In the matter of:

CWP. No. 13351/2025-titled as Sh. Raj Kumar Saklani, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Raj Kumar Saklani, Headmaster, who is presently working in GHS Sargha, Distt. Kullu, H.P. has filed CWP No. 13351/2025- titled as Raj Kumar Saklani, Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Sargha, Distt. Kullu, H.P to nearby his native place in Distt Mandi, H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 20-08-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"4. Consequently, in view of the above, the present petition is disposed of, reserving liberty to the petitioner to file representation to the competent authority within a period of one week, detailing therein vacant station of his choice, where he can be posted in terms of transfer policy, which in turn, shall be decided by the competent authority expeditiously, preferably within a period of three weeks, taking note of transfer policy, which certainly enables an employee working in hard area to seek transfer from hard area to soft area after his/her having completed normal tenure of posting. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate orders and would also take note of provision contained in the transfer policy with regard to adjustment of an employee nearing retirement, especially when petitioner is due to retire with a period of less than two years. Pending applications, if any, also stand disposed of."

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 09-09-02025. He attended the same and submitted his representation in this office on 11.08.2025, vide which he has requested that he is on verge of retirement on 30-04-2027. So, he may be transferred from GHS Sargha, Distt. Kullu, H.P. to nearby his native place in Distt. Mandi, H.P. against vacancy.

On the perusal of the record, it is found that the petitioner is working in GHS Sargla, Distt. Kullu, H.P. since 17-07-2023 which is a hard area and he has almost completed his normal tenure at his present place of posting. The petitioner is going to be retire on 30-04-2027. He has given three stations of his choice at Distt. Mandi, H.P. At present the post of Headmaster is lying vacant at GHS Rekhera, Diatt. Mandi, H.P. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred from GHS Sargha, Distt. Kullu, H.P. to GHS Rakhera, Distt. Mandi, H.P., against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
