In the matter of: CWP.No.20530/2025- titled as Anil Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Anil Kumar, TGT(NM) presently working in GMS Sullo u/c GSSS Aura, Distt. Chamba has filed CWP. No.20530/2025 titled as Anil Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Sullo u/c GSSS Aura, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 24.12.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWPs with the following directions/Order :-

"Having regard to the afore-submissions, but without examining the merits of the matter, this writ petition is disposed of with direction to respondent No.2/ competent authority to consider and decide the aforesaid representation of the petitioner dated 22.09.2025 (Annexure P-4) in accordance with law and applicable transfer policy within a period of two weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any ."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 16.01.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Sullo u/c GSSS Aura, Distt. Chamba to GSSS Rait or GBSSS Dharamshala or GSSS Zamanabad or GMS Lanzhani u/c GSSS Gharoh, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner had earlier been transferred from GMS Sullo u/c GSSS Aura, Distt. Chamba(Tribal area) to GSSS Jassai, Distt. Kangra(Soft area), against vacancy vide this Directorate letter dated 01.09.2025 in view of CWP No. 9477 of 2025 but he did not join at the transferred place and submitted that the transfer was not as per his choice. At present, no vacancy is available in the schools mentioned by the petitioner for transfer.

Therefore, keeping in view the position stated above, the representation of the petitioner has been considered and rejected due to non-availability of vacancies at the requested stations. The petitioner may submit a fresh representation in future as and when vacancies arise, which shall be considered separately as per the transfer policy.

The representation of the petitioner is disposed of after due consideration.

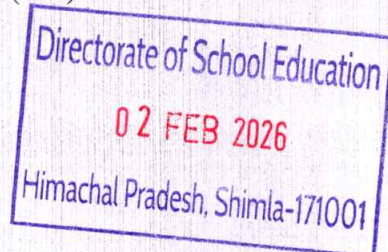
