ORDER

In the matter of:- CWP No. 1059/2026-titled as Partap Singh, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 1059 of 2026 in the Hon'ble High Court vide which sought his transfer from GHS Dhar under complex GSSS Jadera Distt. Chamba to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on dated 09.01.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

“In view of the above, present petition is disposed of with the direction to respondents to consider and decide the pending representation of the petitioner expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon”

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 30.01.2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Partap Singh, TGT (Arts), submitted fresh representation and stated that he is working at GHS Dhar under complex GSSS Jadera Distt. Chamba and requested for transfer/adjustment at GMS Bhaloon u/c GMSSS Matlahar, GSSS Sugh Bhatoli, GHS Mastgarh u/c GUSSS Amni, GMS Pandhu u/c GSSS Badanj, or GMS Nagal u/c GSSS Diana Distt. Kangra on account of completion of his normal tenure of posting at present place of posting.

From the perusal of the record, it is found that Sh. Partap Singh, TGT (Arts), has been working at from GHS Dhar under complex GSSS Jadera Distt. Chamba since 27.06.2022 wherein 44 students are enrolled and petitioner has completed his normal tenure at present place of posting. Further, at present post of TGT (Arts) is lying vacant in GSSS Sugh Bhatoli Distt. Kangra wherein 100 students are enrolled.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Sh. Partap Singh, TGT (Arts) posted at GHS Dhar under complex GSSS Jadera Distt. Chamba is hereby transferred to GSSS Sugh Bhatoli Distt. Kangra against vacancy without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
