**ORDER** 

Whereas, the petitioner namely Smt.Princi Sharma, TGT and under order of posting on her promotion as Lect.(School New)(Hindi) and posted at GSSS Bahadpur (Kgr) on dated 21.08.2025. But later on her promotion order has been modified to GSSS Charri (Kgr) on dated 27.08.2025 but she could not be join there due to no vacancy at GSSS Charri (Kgr). She has filed CWP No. 16273/2025 titled as Princi Sharma vs State of HP. This petition was listed on 15.10.2025 when the same was finally disposed with the directions to respondents as under:-

"True it is that petitioner after her promotion cannot seek posting at one particular school, but once it is not in dispute that after her having been promoted, she pursuant to order passed by the competent authority had gone to Charri for joining, but on account of transfer of some other person, she was unable to join, coupled with the fact that posts are lying vacant at the stations indicated by the petitioner in the representation, this Court sees no impediment in issuing direction to the respondents to consider and decide the representation dated 28.08.2025 (Annexure P-4) of the petitioner expeditiously, preferably within a period of two weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order, taking note of the fact that despite there being promotion order issued by the respondents, petitioner herein has not been able to get posting order till date and at present posts are lying vacant in the schools indicated by the petitioner in her representation. Needless to say, petitioner herein shall be entitled to seniority qua the post of Lecturer from the date she was promoted against the post in question. Pending applications, if any, also stand disposed of."

And whereas, in compliance of Hon'ble High Court order dated 15.10.2025, the petitioner was called for personal hearing on 09.12.2025 and she was present on this date. During the course of hearing petitioner has requested that she may be adjusted anyone of the station i.e GSSS Tiara, GSSS Birta, GSSS Daulatpur, GSSS Shamirpur Distt. Kangra against vacancy.

And whereas, while examined her representation it is found that at present the post of Lect.(Hindi) is lying vacant in all stations.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner has been considered and allowed. The petitioner i.e Smt.Princi Sharma Lect.(Hindi) is being adjusted at GSSS Tiara (Kgr) against vacancy as per her choice alongwith necessary extension in joining time upto 16.12.2025. Hence representation stands disposed of.

May inform the parties accordingly.
