## "ORDER"

Whereas the petitioner Sh. Datt Ram, Lect./Lect.(SN) Biology is under order of transfer from GBSSS Sundernager, Distt. Mandi to GBSSS Nalagarh, Distt. Solan working at GBSSS Nalagarh, Distt. Solan vice Smt Ira Kapoor, Lect./Lect.(SN) Biology & vice versa by clubbing his previous stay within radius of 30 KM. Feeling aggrieved the filed CWP No 15817/2025 titled as Datt Ram Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 07.10.2025 when the same was finally disposed with the directions to respondents as under:-

"Having regard to the nature of prayer and order proposed to be passed, this Court sees no necessity to call for reply on behalf of the respondents, who are otherwise represented by Mr. Rajan Kahol, learned Additional Advocate General. Learned Additional Advocate General states that once it is not in dispute that petitioner has already completed normal tenure of posting at present place of posting, coupled with the fact that transfer order has been passed pursuant to order dated 11.09.2025 passed by this Court in CWP No. 14711 of 2025, no illegality can be said to have been committed by the respondents, while passing the impugned transfer order.

Since it is quite apparent from the pleadings adduced on record by the petitioner that he has already completed normal tenure of posting at Government Boys Senior Secondary School, Sundernagar, there appears to be no justification to interfere with the impugned transfer order and as such, same is upheld. However, having taken note of adverse family circumstances of the petitioner as has been apprised to this Court during the proceedings of the case, this Court without going into the merits of the case, deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority for his adjustment at a 3 convenient station on account of adverse family circumstances within a period of one week, which in turn, shall be decided by the competent authority expeditiously, preferably within a period of ten days. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order, taking note of transfer policy formulated by the Government of Himachal Pradesh, which enables an employee to seek transfer/ adjustment on the ground of adverse family circumstances as well as couple case. Till the time, representation, if any, filed by the petitioner within a period of one week, is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."

And whereas upon passing of above directions, the representation of petitioner has been perused and examined and it has been observed that he has requested for his adjustment either at GSSS Jarol,(Mandi)/ GSSS Mahadev, (Mandi)/ GSSS Phangwas, (Mandi) against longer stayee by clubbing his/ her previous stay with in radius of 30 K.M.

And whereas as per direction passed by the Hon' ble High Court as above, the applicant was called to appear in this office for personal hearing on 15.10.2025 and was present on this date. During the course of hearing the applicant has pleaded that his relief as though this school i.e GBSSS Nalagarh, Distt. Solan is located at a distance of approximately 80 K.M from his native place and his old mother lives with his at home, whose health is not good due to which no one else at home to take care of her.

And whereas, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and the petitioner i.e Sh. Datt Ram, Lect./Lect.(SN) Biology is being adjusted/ transferred to GSSS Phangwas, Distt. Mandi vice Sh. Pawan Kumar, Lect./Lect.(SN) Biology & vice versa, with TTA /JT. Accordingly representation in r/o petitioner i.e Sh Datt Ram, Lect./ Lect. (SN) Biology stand disposed.
