ORDER

Whereas, Smt. Nagendra Kumari, Lecturer (School-New) (English) was filed CWP No. 104332025 before the Hon'ble High Court for seeking her transfer from GSSS Thaltukhod, Distt. Mandi to one of the stations of her choice, on account of the fact that she has already completed normal tenure of posting in hard area.

The case was listed before the Hon'ble Court on 30.6.2025 when the case was disposed of with the following directions:-

“Since, it is quite apparent from the adverments made in the petition that petitioner is working in hard area for more than three years, coupled with the fact that Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer/adjustment from hard area to soft area after his/her completion of normal tenure of posting i.e. two winters and three summers, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide her pending representation (Annexure P-1) expeditiously, preferable, within a period of three weeks from today. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity to being heard to the petitioner and pass appropriate orders thereupon taking note of Transfer Policy.

And whereas, as per the direction passed by the Hon'ble High Court on 30.6.2025, petitioner was called to appear in person on dated 23.07.2025. During the course of hearing, petitioner has requested that she has completed her normal tenure at GSSS Thaltukod (MND) which fall in hard area and unable to continue serve there due to adverse family circumstance and requested to transfer her one of the stations of her choice i.e. GSSS GGSSS Joginder Nagar/GBSSS Joginder Nagar/GSSS Harabag/GSSS Chauntra/GSSS Gumma, Distt. Mandi.

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and the petitioner i.e. Smt. Nagendra Kumari, Lecturer (School-New) (English) is being transferred from GSSS Thaltukhod (MND) to GSSS (B) Joginder Nagar against vacancy without TTA/JT as per petitioner request.

With these observations, representation stands disposed of.
