
In the matter of:- CWP No. 20976/2025-titled as Vidya Sagar, TGT (Arts) V/s. State of HP.

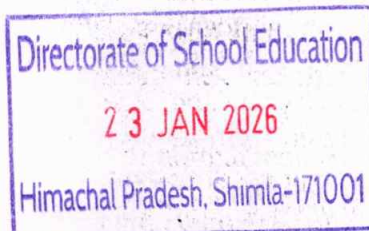

ORDER

In the matter of: CWP No. 18165/2025- titled as Jyoti Gupta Vs. State of H.P.
and others.

Whereas, Jyoti Gupta , TGT (NM) presently working in GMS Surajpur u/c GSSS Puruwala Distt. Sirmour has filed CWP. No. 18165/2025- titled as Jyoti Gupta, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that she may be transferred from GMS Surajpur u/c GSSS Puruwala Distt. Sirmour to one of the stations of her choice in Distt. Una. The case of the petitioner was listed before the Hon'ble High Court on 22.11.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"True, it is that it is the sole prerogative of the employer to post an employee anywhere in the State, but once transfer policy formulated by State of Himachal Pradesh, provides for minimum tenure of three years coupled with the fact that petitioner has already completed normal tenure at present place of posting, this Court sees no impediment in as much as issuing direction to the respondents to consider and decide representation of the petitioner, expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of the fact that husband of the petitioner is also working as TGT (Non-Medical) at Government Senior Secondary School Kinnu, Tehsil Amb District Una, Himachal Pradesh. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 16.01.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GMS Surajpur u/c GSSS Puruwala Distt. Sirmour to GMS Nagarwala u/c GSSS Jadla Distt. Una against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Surajpur u/c GSSS Puruwala Distt. Sirmour since 11.03.2019. At present, one post of TGT (NM) is lying vacant at GMS Nagarwala u/c GSSS Jadla Distt. Una.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.

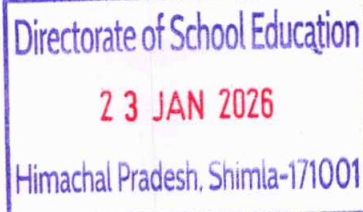
