ORDER

In the matter of:-

CWP No. 15481/2025-titled as Kapil Dev, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer at one of the station of his choice. The present CWP was listed before the Hon'ble High Court of H.P. on 25.09.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 15-10-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Kapil Dev, TGT (Arts), submitted fresh representation and stated that he has completed his normal tenure at GMS Jamnu u/c GSSS Tattapani and his father is 75 years old and there is nobody who can properly take care of him as he is suffering frm old age ailments so that requested for adjustment at GHS Salnoo u/c GSSS Kandraur Distt Bilaspur.

From the perusal of the record, it is found that Sh. Kapil Dev, TGT (Arts), is posted at GMS Jamnu u/c GSSS Tattapani, District Mandi, w.e.f. 12.08.2021, and the institution, is classified as a soft area within District Mandi, where 15 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right."

Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GMS Jamnu u/c GSSS Tattapani Distt Mandi. It is further considered that the transfer of the petitioner at this stage would adversely affect the studies of the students during the mid-academic session. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
