## ORDER

Whereas, petitioners of CWP No.1818 of 2024—Manohar Lal Sharma & ors. and CWP No. 11370 of 2025–Virender Singh & Anr., have filed civil writ petitions in the Hon'ble High Court HP with the request to issue direction to the respondent authorities to consider the case of the petitioners being TGT (Hindi/Sanskrit) and grant pay scale of TGT and all consequential benefits and also grant them promotional avenue to the post of Lecturer (School-Cadre) terms of the judgment passed by the Hon'ble Court in CWP No. 2171/2023 titled as Hem Raj vs. State of H.P. & ors.

Above court cases have been disposed of by the Hon'ble High Court of HP. Operative part of the judgment passed in CWP No. 1818/2024—Manohar Lal Sharma & ors. is as under:-

- "3. At the very outset, learned counsel for the petitioners has submitted that the issue involved in the instant petition has already been adjudicated upon by this Court vide judgment dated 4.9.2023, passed in CWP No. 2171 of 2023, titled as Hem Raj & others vs. State of H.P. & others along with connected matters. He further submits that the petitioners have already submitted their respective representations to the Secretary Education to the Government of Himachal Pradesh, copies whereof have been placed on record as Annexure P-5. As per him, the petitioners shall be satisfied, at this stage, in case time bound directions are issued to the respondents to consider and decide the representations of the petitioners in light of the aforesaid judgment.
- 4. Prayer being innocuous is not opposed. Accordingly, the instant petition is disposed of with direction to the respondents to consider and decide the representations (Annexure P-5) of the petitioners within eight weeks from today strictly in terms of the aforesaid judgment by passing a detailed and reasoned order. Pending applications, if any, also stand disposed of."

Operative part of the judgment passed in CWP No. 11370 o 2025-Virender Singh & Anr. is as under:-

- "3. Learned counsel for the petitioners submits that the petitioners have preferred a representations dated 12.06.2025 [Annexure P-1 (Colly)] to respondent No. for claiming the above relief.
  - Learned counsel further submitted that the petitioners would be content, in case, they are permitted to submit comprehensive representations to the respondents/ Competent Authority seeking the relief prayed for by them in the writ petition, whereafter, respondents/Competent Authority, be directed to decide the representations to be made by them, in a time bound manner. Learned Deputy Advocate General has no objection to this prayer.
- 4. in view of above submissions, the present petition is disposed of by permitting the petitioners to make comprehensive representations to the respondents/ competent Authority, within a period of two weeks from today, who shall in turn, consider and decide the same, in accordance with law, in light of aforesaid decision, within a further period of six weeks by passing order, which shall also be communicated to the petitioners. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

Whereas, the case of the petitioners has been examined in compliance to the judgment passed in CWP No. 2171/2023 titled as Hem Raj vs. State of HP and taking into

consideration the Notification of the Government issued vide No. EDC-B(15)15/2011 dated 20-08-2022 which says, "all Bachelor of Education (B.Ed.) qualified and Teacher Eligibility Test (TET) passed Shastris and Language Teachers (LTs) are to be designated as Trained Graduate Teachers (Sanskrit) and Trained Graduate Teachers (Hindi) in their respective pay scale structure." Therefore, no financial benefits were granted to these categories, and merely their nomenclature was changed to TGT (Sanskrit) and TGT(Hindi) and that too for only those Shastri/Language Teachers who are B.Ed. qualified and TET pass.

Whereas, the Hon'ble High Court in the said CWP No. 2171/2023, has passed the following judgment on 04-09-2023 at Para 7:-

"In view of the discussion in para 5 above, these writ petitions are allowed. The respondents are directed to grant the pay scale of the post of Trained Graduate Teachers(TGTs) and promotional avenue to the post of Lecturer(School New) to the petitioners (Shastri (Sanskrit) and Language Teacher (Hindi)- now-redesigned as TGT(Sanskrit) and TGT(Hindi) respectively, in terms of notification dated 20-08-2022, as is being given to TGT(Medical), TGT(Non- Medical), and TGT(Art). This shall be admissible to them from the date of issuance of notification dated 20.08.2022. The exercise be completed within seven weeks from today, miscellaneous applications, if any, also stand disposed of."

Whereas, the matter of Sh. Hem Raj & others has already been examined at Govt. level in compliance to the judgment passed by the Hon'ble High Court in CWP No. 2171/2023 titled as Hem Raj vs. State of HP, CWP No. 8389/2023 to 8398 of 2023 alongwith others connected matters and Execution Petition No. 168 & 170 of 2024 and thereafter the Govt. has passed detailed speaking orders on 20.05.2024 and subsequently addendum on 17.09.2024. Operative part of speaking order is as under:-

"Whereas, Execution Petition No. 168 & 170 of 2024 were further filed in this matter in the Hon'ble High Court & the Hon'ble Court vide order dated 19.03.2024 had directed to decide the representation within a period of six weeks.

Thus, as per the directions of the Hon'ble High Court in above mentioned CWPs & Execution Petitions, their representation dated 18-03-2023 of State President Rajkiya Bhashai Adhyapak Sangh, Himachal Pradesh has been examined and considered by the undersigned. It has been found that their main prayer is to consider the candidature of redesignated TGT (Hindi and TGT (Sanskrit) in the panel for promotion to the next higher posts i.e. Lecturer/headmaster, as the panel of eligible officials are being prepared by the Deputy Directors (Elementary Education).

It would be pertinent to mention here that the petitioners have been working as Shastri & Language Teachers in the Elementary Education Department and they were redesignated as TGT (Sanskrit) and TGT (Hindi) in their respective scales vide Notification dated 20-08-2022. Since, they have re-designated as TGTs vide the notification mentioned supra, the pay scales and promotional avenues are admissible to them from the date of issuance of said notification i.e. 20.08.2022. The orders of Hon'ble High Court as mentioned in para 3 above also direct the same.

Thus, after considering the whole matter, I am of considered view that such redesignated TGTs (Sanskrit/Hindi) are entitled to be considered for promotion as Lecturers/Headmasters and thus they are considered for the same. However, tenure or service of such re-designated Sanskrit/Hindi Teachers as TGT shall be considered from the date of their re-designation as TGTs which in this case, is the date of notification dated 20-08-2022. It is pertinent to mention that as per the R&P Rules for the post of Lecturer (School-New) and Headmaster, there is specified period of minimum length of service as TGT (5/8 years) for a candidate to become eligible for promotion. Thus, these teachers shall become eligible

for promotion only after completion of required length of service which is to be counted w.e.f. 20.08.2022, subject to the final outcome of LPA No. 86/2024 (State vs. Hem Raj)" It is pertinent to mention here that above judgment passed in the Hem Raj case under CWP No. 2171/2023 has been assailed by the Department by way of filing the LPA No. 86/2024 in the Hon'ble High Court which has also been admitted in the Hon'ble High Court.

Therefore, after considering the whole matter, the petitioners are hereby considered only for promotion as Lecturer/Headmaster subject to final outcome of LPA No. 86/2024. However, tenure of service of the petitioners shall be considered from the date of their re-designation as TGT i.e. the date of notification dated 20-08-2022 or from the date of passing of TET/B.Ed examination which is later. It is pertinent to mention that as per the R&P Rules for the post of Lecturer (School-New) and Headmaster, wherein specified period of minimum length of service as TGT (5/8 years) for a candidate to become eligible for promotion. Thus, the petitioner shall become eligible for promotion only after completion of required length of service which is to be counted w.e.f. 20.08.2022 or from the date of passing of TET/B.Ed examination which is later.

Hence, the representation of the petitioners is hereby considered and decided

## **ORDER**

In the matter of : CWP No. 13587/2025 titled as Namit Kapatiya & others vs. State of HP and others.

Whereas, the petitioners in the above court case have filed CWP No. 13587/2025 titled as Namit Kapatiya & others in the Hon'ble High Court HP which was disposed of by the Hon'ble High Court on 05.09.2025 with the following judgment:-

"Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representations (Annexure P-3 Colly) of the petitioners expeditiously, preferably within a period of six weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioners and pass detailed speaking order thereupon taking note of the judgment rendered by Coordinate Bench of this Court in Hem Raj (supra), wherein issue otherwise sought to be decided in the instant proceedings already stands adjudicated. Liberty is reserved to the petitioners to file appropriate proceedings in appropriate Court of law, if they still remain aggrieved. Pending applications, if any, also stand disposed of".

Whereas, in compliance to the above judgment passed by the Hon'ble High Court the petitioners were called for personal hearing on 27.09.2025 and heard in length. During course of hearing the petitioners requested that their case may kindly be considered in light of the judgment passed by the Hon'ble High Court of HP in CWP No. 2171/2023 titled as Hem Raj & others vs. State of HP.

Whereas, the case of the petitioners has been examined in compliance to the judgment passed in CWP No. 2171/2023 titled as Hem Raj vs. State of HP and taking into consideration the Notification of the Government issued vide No. EDC-B(15)15/2011 dated 20-08-2022 which says, "all Bachelor of Education (B.Ed.) qualified and Teacher Eligibility Test (TET) passed Shastris and Language Teachers (LTs) are to be designated as Trained Graduate Teachers (Sanskrit) and Trained Graduate Teachers (Hindi) in their respective pay scale structure." Therefore, no financial benefits were granted to these categories, and merely their nomenclature was changed to TGT (Sanskrit) and TGT(Hindi) and that too for only those Shastri/Language Teachers who are B.Ed. qualified and TET pass.

Whereas, the Hon'ble High Court in the said CWP No. 2171/2023, has passed the following judgment on 04-09-2023 at Para 7:-

"In view of the discussion in para 5 above, these writ petitions are allowed. The respondents are directed to grant the pay scale of the post of Trained Graduate Teachers(TGTs) and promotional avenue to the post of Lecturer(School New) to the petitioners (Shastri (Sanskrit) and Language Teacher (Hindi)- now-redesignated as TGT(Sanskrit) and TGT(Hindi) respectively, in terms of notification dated 20-08-2022, as is being given to TGT(Medical),

TGT(Non-Medical), and TGT(Art). This shall be admissible to them from the date of issuance of notification dated 20.08.2022. The exercise be completed within seven weeks from today, miscellaneous applications, if any, also stand disposed of."

Whereas, the matter of Sh. Hem Raj & others has already been examined at Govt. level in compliance to the judgment passed by the Hon'ble High Court in CWP No. 2171/2023 titled as Hem Raj vs. State of HP, CWP No. 8389/2023 to 8398 of 2023 alongwith others connected matters and Execution Petition No. 168 & 170 of 2024 and thereafter the Govt. has passed detailed speaking orders on 20.05.2024 and subsequently addendum on 17.09.2024. Operative part of speaking order is as under:-

"Whereas, Execution Petition No. 168 & 170 of 2024 were further filed in this matter in the Hon'ble High Court & the Hon'ble Court vide order dated 19.03.2024 had directed to decide the representation within a period of six weeks.

Thus, as per the directions of the Hon'ble High Court in above mentioned CWPs & Execution Petitions, their representation dated 18-03-2023 of State President Rajkiya Bhashai Adhyapak Sangh, Himachal Pradesh has been examined and considered by the undersigned. It has been found that their main prayer is to consider the candidature of re-designated TGT (Hindi and TGT (Sanskrit) in the panel for promotion to the next higher posts i.e. Lecturer/headmaster, as the panel of eligible officials are being prepared by the Deputy Directors (Elementary Education).

It would be pertinent to mention here that the petitioners have been working as Shastri & Language Teachers in the Elementary Education Department and they were re-designated as TGT (Sanskrit) and TGT (Hindi) in their respective scales vide Notification dated 20-08-2022. Since, they have re-designated as TGTs vide the notification mentioned supra, the pay scales and promotional avenues are admissible to them from the date of issuance of said notification i.e. 20.08.2022. The orders of Hon'ble High Court as mentioned in para 3 above also direct the same.

Thus, after considering the whole matter, I am of considered view that such redesignated TGTs (Sanskrit/Hindi) are entitled to be considered for promotion as Lecturers/Headmasters and thus they are considered for the same. However, tenure or service of such re-designated Sanskrit/Hindi Teachers as TGT shall be considered from the date of their redesignation as TGTs which in this case, is the date of notification dated 20-08-2022. It is pertinent to mention that as per the R&P Rules for the post of Lecturer (School-New) and Headmaster, there is specified period of minimum length of service as TGT (5/8 years) for a

candidate to become eligible for promotion. Thus, these teachers shall become eligible for promotion only after completion of required length of service which is to be counted w.e.f. 20.08.2022, subject to the final outcome of LPA No. 86/2024 (State Vs. Hem Raj)"

It is pertinent to mention here that above judgment passed in the Hem Raj case under CWP No. 2171/2023 has been assailed by the Department by way of filing the LPA No. 86/2024 in the Hon'ble High Court which has also been admitted in the Hon'ble High Court.

Whereas, on perusal of the record of qualification of the petitioners it has been found that the petitioners have passed B.Ed. and TET examination.

Therefore, after considering the whole matter, the petitioners are hereby considered only for promotion as Lecturer/Headmaster subject to final outcome of LPA No. 86/2024. However, tenure or service of the petitioners shall be considered from the date of their re-designation as TGT i.e. the date of notification dated 20-08-2022 or from the date of passing of TET/B.Ed examination which is later. It is pertinent to mention that as per the R&P Rules for the post of Lecturer (School-New) and Headmaster, wherein specified period of minimum

length of service as TGT (5/8 years) for a candidate to become eligible for promotion. Thus, the petitioner shall become eligible for promotion only after completion of required length of service which is to be counted w.e.f. 20.08.2022 or from the date of passing of TET/B.Ed examination which is later.

Hence, the representation of the petitioners is hereby considered and decided accordingly. Inform all the concerned accordingly.
