**ORDER**

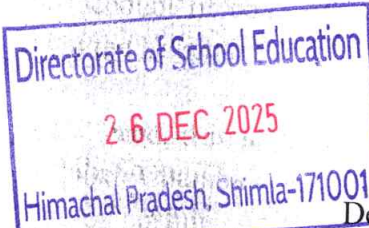
In the matter of:- CWP No. 17309/2025-titled as Anju Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 17309 of 2025 in the Hon'ble High Court vide which sought his transfer from GMS Shoon u/c GSSS Sechunala Distt. Chamba HP to soft area. The present CWP was listed before the Hon'ble High Court of H.P. on 07.11.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 15-12-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Anju Kumar, TGT (Arts), submitted fresh representation and stated that he is working at GMS Shoon u/c GSSS Sechunala Distt. Chamba (Tribal area) and requested for transfer/adjustment either to GMS Lanzhani u/c GSSS Gharoh, GMS Sudher u/c GSSS Gharoh, GSSS Gharoh, GHS Dodombh, GSSS Khaniyara Khas, GSSS Bhali, GHS Malan Distt. Kangra on account of completion of normal tenure as well as on couple case basis as his wife is also working in the Education Department.

From the perusal of the record, it is found that Sh. Anju Kumar, TGT (Arts), is posted at GMS Shoon u/c GSSS Sechunala Distt. Chamba (i.e. Tribal area) since 16.01.2019, he has completed his normal tenure at present place of posting. At present one post of TGT (Arts) is lying vacant at GSSS Bhali Distt. Kangra wherein about 125 students are enrolled, which also falls within the choice station of the petitioner.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and as per transfer policy clause 5.4 "concession to couples case" the petitioner, Sh. Anju Kumar, TGT (Arts) posted at GMS Shoon u/c GSSS Sechunala, Distt. Chamba is hereby transferred/adjusted at GSSS Bhali, Distt. Kangra against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
