OFFICE ORDER

Whereas, in Ex. Pet. No. 237/2024 in TA No. 4574/2017 titled as Anita Bhardwaj TGT(Med) Vs State of H.P. and ors. The Hon'ble High court of HP has passed the following orders/judgments:-

"The petition is accordingly disposed of with the direction that in case the needful is not done within six weeks from today, then the petitioner may file an appropriate application for revival of these proceedings. Pending miscellaneous application(s), if any also stand disposed of accordingly".

In compliance to the order of the Hon'ble High court of HP, the record of the petitioner examined in detailed and found that the petitioner, seeking benefits to count the contractual/tenure service rendered by her for the purpose of earned leave in the analogy of CWP No. 5043/2022- titled as Sunita Sangroli Vs State of HP and others. The petitioner has also claimed for financial benefits.

Whereas, the judgment passed by the Hon'ble High court of HP in CWP No. 5043/2022- titled as Sunita Sangroli Vs State of HP and others is reproduced as under:-

"13. In result, the petition is allowed. Office memorandum dated 06.07.2020 (Annexure P-7), is quashed and set aside. Respondents are directed to grant benefit of earned leave to the petitioner from the initial date of contract appointment i.e. 25.06.1997 within eights weeks from today.

14. The petition is, accordingly, disposed of, so also the pending miscellaneous application(s), if any.

Whereas, the Govt. of Himachal Pradesh vide their letter No. EDN-B-E(3)-4/2024 dated 01.08.2024 clarified regarding accumulation of earned leave from date of regularization of services retrospectively in compliance to the judgment passed by the Hon'ble High Court of Himachal Pradesh in CMP No. 16892 of 2023 Sunita Sangroli versus State of Himachal Pradesh & Ors. decided on 05.01.2024 vide which it is directed to implement the order of Hon'ble High Court and credit the earned leave in the account of petitioners i.e. Sunita Sangroli (in CWP No. 5043/2022 and Praveen Kumar (in Ex Pet. No. 551 of 2024) alongwith other similarly situated petitioners with effect from initial date of their regularization without any financial benefits.

Whereas, in compliance to the orders passed by Hon'ble High Court of HP and further approval conveyed by the Govt. vide letter dated 01.08.2024, the department has

implemented the said judgment in various CWPs vide office order No. EDN-H(2)B(8)11/2023-Leave(Court Cases) dated 17.12.2024. and 11.09.2025.

The matter of financial benefits on account of earned leave was taken up with the Government, and the Government has issued the directions vide letter No. EDUC-E05/25/2024 dated 25.09.2025 (Copy enclosed) that only earned leave be credited in favour of the petitioners, without any financial benefits.

Accordingly, all the Dy. Directors of School Education, HP have been directed to comply with the directions in this department letter No. EDN-H(2)B(8)11/2023-Leave(Court Case) dated 17.12.2024 & 11.09.2025.

The petitioner of present petition is entitled to earned leave with effect from the initial date of her appointment i.e on tenure basis, strictly without any financial benefits. The DDO and Controlling Officer concerned is hereby directed to credit the earned leave to the petitioner's leave account without granting any financial benefits. Entries to this effect should be made in the individual concerned's service book, with intimation to this Directorate.
