Whereas, Sh. Vinod Kumar, TGT (NM) preferred CWP No. 15416/2024 titled as Vinod Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Bagher, U/C GMSSS Bharian Kothi, Distt. Chamba, H.P. to nearby home station in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 17-12-2024, when the Hon'ble High Court has passed the following orders:-

3. "Looking to the limited grievance of the petitioner, the present writ petition is disposed of by directing respondent No. 2/competent authority to consider and decide the representation dated 26-09-2024 of the petitioner, in accordance with law and applicable Transfer Policy, within a period of two weeks from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court, the petitioner has submitted his representation in this office on 31-12-2024, vide which he has requested that he may be transferred from GMS Bagher, U/C GMSSS Bharian Kothi, Distt. Chamba, H.P. to nearby native place in Distt. Kangra, H.P., against vacancy / against longer stay by clubbing his/her previous stay radius of 30 Kms. on medical grounds.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Bagher, U/C GMSSS Bharian Kothi, Distt. Chamba, H.P. since, 25-03-2022 which is a sub-cadre difficult area and has completed the normal tenure of 2 winters and 3 summers at present place of posting. One Sh. Kishori Lal, TGT(NM) is working in GSSS Ganoh, Distt. Kangra, H.P. since 30-09-2023. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby transferred without TTA/JT from GMS Bagher, U/C GMSSS Bharian Kothi, Distt. Chamba, H.P. to GSSS Ganoh, Distt. Kangra, H.P. vice Sh. Kishori Lal, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Kishori Lal, TGT(NM). The representation of the petitioner is disposed of accordingly.
