ORDER

In the matter of: CWP No. 1858/2026- Smt. Neena Devi, TGT(NM) Vs. State of H.P. and others.

Whereas, Smt. Neena Devi, TGT(NM) presently working in GHS Kalatha u/c GSSS Killour, Distt. Sirmour has filed CWPNo.1858/2026 titled as Smt. Neena Devi Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred from GHS Kalatha u/c GSSS Killour, Distt. Sirmour to one of the stations of her choice in Distt. Una. The case of the petitioner was listed before the Hon'ble High Court on 06.03.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Accordingly, as prayed for, this petition is disposed of with the direction that let representation (Annexure P-2) of the petitioner be decided by the Competent Authority, in the light of the averments contained therein, within a period of 6 weeks' from today, after affording an opportunity of hearing to the petitioner, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.03.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GHS Kalatha u/c GSSS Killour, Distt. Sirmour to GSSS Chartgarh or GSSS Basdehra, Distt. Una, against the vacancy arising due to retirement of the present incumbent on 31st March, 2026.

After perusal of relevant record, it is revealed that the petitioner has been working in GHS Kalatha u/c GSSS Killour, Distt. Sirmour since 16.11.2019 and has completed her normal tenure of three years. Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby transferred from GHS Kalatha u/c GSSS Killour, Distt. Sirmour to GSSS Basdehra, Distt. Una, against the vacancy arising due to the retirement of the present incumbent on 31.03.2026, without TTA/JT on her own request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
