Opening Remarks



At the outset, Dy. Mission Director, NHM, welcomed the Chairperson and all participants. He submitted that this briefing meeting has been organised to brief key stakeholders on the rollout of the Tobacco-Free Youth Campaign (TFYC) 3.0, scheduled for launch on 9th October 2025 across India. Dr. Ravinder Kumar, State Programme Officer (NTCP), made a presentation on burden of tobacco use in India and in Himachal Pradesh, aims and objectives of TFYC 3.0 and strategies and activities to be carried out during the 60-day campaign period. He also made a presentation on the role and responsibilities of the key line departments for successful roll out of the campaign and overall tobacco control in the State. Each aspect of the strategies and activities and issues discussed in detail and the following actionable points recommended.

Actionable Points

1. Common Directives and actionable points for All Departments and Institutions

- All government offices and workplaces, including hospitals, will be declared Tobacco-Free Premises. To ensure compliance, the respective Heads of Departments will issue D.O. letters instructing all subordinate offices across the State to adhere to this directive within a fortnight.
- Mandatory Display of 'Tobacco-Free Premises' Signage. A large signage
 (120×60 cm) must be installed at the main entrance of each office or
 workplace building. Additionally, multiple smaller signages (60×30 cm) should
 be placed near lifts, corridors, and on each floor. These signages must also
 indicate the name and designation of the officer to whom violations can be
 reported. Display of these signages is a legal requirement under COTPA
 2003, and the cost of printing and installation shall be borne by the respective
 offices or workplace In-charges.
- A tobacco disposal box to be placed at each entry gate for staff/visitors.
- Repeated violations by government officials shall invite disciplinary action under CCS (CCA) Rules, 1965, in addition to penalties under COTPA, 2003.
- Audio-video awareness content on tobacco harms will to be displayed on LED screens in public waiting areas. The standardized AVs will be provided by State Tobacco Control Cell of NHM.
- Staff using tobacco to be linked to cessation services at nearby health facilities or National Quitline (1800-11-2356).
- During the campaign period, every staff member in all offices and workplaces shall take the QR code-based 'No Tobacco' Pledge as well as the 'Nasha Mukt Bharat' Pledge, demonstrating their commitment to a tobacco-free and substance-free environment.

2. District Administration

- Deputy commissioner will lead and coordinate inter-sectoral implementation of TFYC 3.0 at the district level.
- · Convene District-Level Coordination Committee Meetings (DLCC) with the

line departments and other related organization.

- Launch the campaign on 9th October 2025 or any other earliest convenient date in all districts.
- Issue DOs/circulars to BDOs for making villages tobacco-free as per MoHFW SOPs
- Issue a D.O. to the DTDO/Deputy Director of the Tourism Department to ensure strict compliance with Section 4 of COTPA 2003 regarding the provisions for Designated Smoking Rooms (DSR) and Designated Smoking Areas (DSA) in hotels, guest houses, and restaurants. DSRs are permitted only in hotels or guest houses with 30 or more rooms, while DSAs are allowed in restaurants with a seating capacity of at least 30 persons. Compliance with COTPA must be made a mandatory requirement for the issuance or renewal of licenses to operate hospitality establishments, ensuring the health and safety of guests and staff. Section 4 of COTPA 2003 also applies to government rest houses across all departments.
- The Government of Himachal Pradesh has notified a District-level Flying Squads. As per the directions and targets issued by the Government of India for TFYC 3.0, each flying squad is required to conduct at least two enforcement drives per week in their respective districts. The District Administration shall monitor the performance of these squads on a weekly-basis. Additionally, the respective Sub-Divisional Magistrates will oversee the performance of Block-level flying squads within their jurisdictions, which are also required to conduct two enforcement drives per week as directed by the Ministry of Health and Family Welfare, Government of India.
- These enforcement drives will focus primarily on locations with high incidences of smoking in public places, including *Dhaha*, restaurants, beerbars, bus stands, bus stops, offices, hospital premises, public transport vehicles, and around educational institutions. These drives will also target shops selling illegal or banned products, such as e-cigarettes, tobacco packs without specified pictorial health warnings, and shops not displaying mandatory health warning signage.
- Additionally, specific enforcement drives will be conducted in establishments providing hukkah (shisha) services within their premises.
- D.O. to be issued from District Administration to Municipal bodies and Department of Panchayati Rej Officers to implement Tobacco Vendors Licensing Act, 2016, and ban on loose cigarettes. Monitoring and monthly follow up with concerned officials
- Holding press briefing about the Tobacco free youth campaign 3.0 by the district administration
- Identify and honour best-performing educational institutions, officials, and volunteers during the Abhiyan.

3. Department of Home (Police)

The police department is the primary law enforcement agency under COTPA

- 2003, PECA 2019, and the Tobacco Vendors Licensing Act 2016.
- Regular review of COTPA and PECA violations may be conducted during the Monthly Crime Review.
- Enforcement of the Juvenile Justice Act (JJA) may be invoked in case of sale
 of tobacco to minors.
- Police officials serve as key members of the State, District, and Block Flying Squads. In accordance with directions from the MoHFW, Government of India, each flying squad is required to conduct at least two enforcement drives per week at the State, District, and Block levels; therefore, the availability of police personnel may be ensured for these drives.
- All police officials above the rank of Head Constable (as notified by the State Government) shall continue to enforce COTPA within their respective jurisdictions, in addition to participation in flying squad enforcement drives.
- Anti-tobacco messages should be integrated into various awareness programs conducted by the Police Department.
- A dedicated session on Tobacco Control and related legal issues should be included in the curriculum of Police Training Academies in the State.
- Any police official or staff member using tobacco may be referred to the tobacco cessation services provided by the Health Department.

Department of Health & Family Welfare (Directorate of Health Services and National Health Mission)

- · Nodal department implementing National Tobacco Control Program.
- Intersectoral coordination with line departments and organization under chairmanship of DC at district level.
- Conduction of State Level Coordination Committee (SLCC) at State level and District Level Coordination Committee (DLCC) in each District
- Providing cessation services through the Tobacco Cessation Centers (provision of NRT and other drugs) at each District Hospitals and major civil hospitals
- Counselling session for tobacco cessations in Nayee Disha Kendra (NDK)
- Technical assistance to Department of Education for declaring Tobacco Free Educational Institutions and collaboration with Panchayati Raj Deptt for making and declaring Tobacco Free Villages
- Implement TB-Tobacco, Tobacco-NCD, Tobacco-NMHP and Tobacco-NOHP collaboration.
- Capacity building of front-line staff for brief advice (AAR strategy) to quit tobacco use
- Capacity building of Law enforcers/Flying squads related to enforcement drive.
- Conducting health talks on Health issues related to tobacco use and TFYC
 3.0 in Doordarshan/Community Radio/FM- At least one activity per week in each district.
- As per targets given by MoHFW, a minimum 30 IEC campaigns will be conducted in each district during 60 days of campaign.

- Principals and Sr. Medical Supdt in all Medical college hospitals to ensure law enforcement within the hospital/institute campus/premises including hostels, canteens
- Providing cessation services through the Tobacco Cessation Centers (provision of NRT and other drugs)
- Session on Harmful effects of Tobacco use may be planned for all students in medical, nursing and pharmacy schools.
- Organize competitions among the students for creating innovative awareness content on Tobacco control
- Print this message on the OPD slip and IPD file of the patients "तंबाकू छोड़ें, जिंदगी चुनें! तंबाकू छोड़ने में मदद के लिए टोल-फ्री हेल्पलाइन पर कॉल करें 1800-11-2356"

7. Department of AYUSH

 Ensure strict implementation of Topacco-Free Educational Institutions (TOFEI) guidelines in Ayurvedic and Pharmacy colleges, both in the public and private sectors, and maintain Tobacco-Free premises in all hospitals under the AYUSH department, A D.O. letter shall be issued by the Director, AYUSH to the respective Principals, Medical Superintendents (MS), DAOs, SDAMOs, and AMOs.

- Enforce COTPA within institute campuses, including hostels and canteens, to grevent tobacco use.
- Provide tobacco cessation services at each AYUSH institution using Brief Advice (AAR strategies), coordinated by the Department of Health.
- Organize educational sessions on the harmful effects of tobacco for BAMS students and Pharmacy students to promote awareness and prevention.
- Print this message on the OPD slip and IPD file of the patients "तंबाकू छोड़ें,
 जिंदगी चुनें! तंबाक छोड़ने में मदद के लिए टोल-फ्री हेल्यलाइन पर कॉल करें 1800-11-2356"
- 8. Excise and Taxation Department
- Officials from the Excise and Taxation Department are already members of the Flying Squad, and their availability may be ensured during all enforcement drives.
- Distributors, wholesalers, and retailers selling tobacco products without the specified Pictorial Health Warnings (PHWs) shall be prosecuted under Section 7 of COTPA 2003.
- Considering the presence of many smuggled or illegal cigarette brands across the State, the Excise & Taxation Department may act in accordance with the relevant Excise & Taxation laws, in addition to enforcement under COTPA.

9. Department of Education

- To conduct series of awareness activities in the educational institution about the harmful effects of tobacco use
- · Mandatory display of standardized signages in campuses.
- Strict enforcement of Section 6 b of COTPA- Institute's head is designated as law enforcer alternatively he/she may report the details of violators to police or flying squads
- Effective implementation of TOFEI guidelines- submission of claims/selfassessment forms from each educational institution with the District Education Officer
- For the campaign period (9 october-8 December 2025), minimum 400 educational institutions are to be made TOFEI guidelines compliant. However efforts will be made to make each educational institution in the state Tobacco Free
- TOFEI guidelines are applicable to all education institutions both in public and private sectors.

10. Department of PR&RD

- Conduct a series of awareness activities on the harmful effects of tobaccouse in each ward, village, and Gram Panchayat.
- Tobacco-Free Village initiatives should be included as an agenda item in Gram Sabha meetings, along with wall paintings depicting the harm of tobacco in Gram Panchayat buildings.
- Organize a series of activities aimed at establishing a Tobacco-Free Village,

in accordance with the SQPs issued by the MoHFW.

- Submit claims for Tobacco-Free Village certification after completion of activities.
- · Link tobacco users to cessation services to help them guit tobacco.
- · Ensure mandatory display of specified signages in villages as per the SOPs.
- · Maintain the Tobacco-Free status of the village once achieved.
- The Government of India has set a target of making at least 30 villages tobacco-free during the campaign period (9 October – 8 December 2025).
- Implement the Tobacco Vendors Licensing Act 2016 and its rules (2018). As
 per State Government notification, the Panchayat Secretary serves as the
 registering authority for issuing tobacco vendor licenses. A D.O. letter shall be
 issued by the Director, Panchayati Raj & Rural Development, to subordinate
 officers at district and sub-district levels to ensure proper implementation of
 the Act.

11. Department of Urban Development

- Providing spaces for displaying awareness hoardings in prominent places in the town/city within municipal limits
- . Enforcement of COTPA 2023, as the municipal officers are law enforcers
 - · Prohibition of Smoking in public places
 - · Tobacco vendors near educational institutions
- Denying spaces for Tobacco Advertisement & sponsorship and surrogate advertisements of tobacco products in the jurisdiction of municipal bodies
- Denying permission to hold any event sponsored by a tobacco company or associates
- Enforcement of legal provision on establishments serving Hukkah
- Enforce the ban on sale of e-Gigarettes in collaboration with police department
- Strict implementation of Himachal Pradesh Municipal Act, 1994 (Section 180, 182) for spitting in public places.
- Anti-tobacco jingles play in the "Swachhata Rath". Department of Health to provide standardized jingles.
- Implementation of Tobacco venders licensing rules 2018 and ban on sale of loose cigaréttes as the Municipal authorities are the registering authorities for issuing the licenses.
- Reducing the tobacco venders' density in the city.
- Make your respective cities model city for implementing Tobacco Vendor Licensing
- Linking the tobacco user staff to cessation services being provided by the health department

12. Role of Tribal Development Department

- Awareness & Education: Conducts awareness drives in tribal schools and villages about the dangers of tobacco.
- Tobacco-Free Campuses: Implements TFYC 3.0 in Eklavya Model



Residential Schools, Ashram schools, and hostels.

- Training & Capacity Building: Trains teachers, youth leaders, and SHGs as tobacco control ambassadors.
- Community Involvement: Engages tribal youth clubs, panchayats, and local leaders for grassroots participation.
- Cultural Integration: Promotes traditional healthy lifestyles and values discouraging substance use.
- Monitoring & Recognition: Tracks implementation and rewards schools maintaining tobacco-free status.

13. Role of HRTC

- Mandatory Display of Signage: Install "Tobacco-Free Premises/Campus" signage at the main entrance of each bus stand. Adoitionally, multiple "No Smoking" signages should be placed at prominent locations within bus stands, such as waiting areas, ticket counters, toilets, and bus stoppage zones, including the name and phone number of the in-charge on each signage.
- Enforcement of Section 4 of COTPA: Compliance at bus stands shall be enforced by the respective Department/Corporation. As per the Act, the incharge of the workplace/establishment is the designated law enforcer for Section 4. Accordingly, a D.O. letter may be issued from the State HQ to the Adda Prabhari in each district to ensure that challans are issued to violators. The enforcement activities in each bus stand will be reviewed by the respective Deputy Commissioner.
- Public Awareness: Display Anti-Tobacco hoardings at bus stands to create public awareness.
- No Smoking Inside Buses: The display of "No Smoking" signage inside buses
 is a legal requirement under COTPA 2003. These instructions should be
 included in a comprehensive D.O. issued from the State HQ to the respective
 Regional/Divisional Managers (RM/DMs) of the department.
- Cessation Support for Staff: HRTC staff who are tobacco users should be linked to tobacco cessation centres, if required.

14. Role of Department of Social Justice and Women Empowerment

- Awareness and Advocacy among youth women and family through SHG, AWW and community network.
- Women and Family-Based Interventions- Women as a change leaders to ensure tobacco free family and communities
- Protection of Vulnerable Groups (women, children and marginalized group)
- Capacity Building and Collaboration- Train the SHGs and NGOs as a Tobacco control Ambassadors- One of the mandatory condition for Tobacco Free Village Initiative.

 Empowerment through Education- Promotes life-skills education and selfconfidence among girls and young women to resist peer pressure and tobacco use

15. Role of the Department of Youth and Sports

- Youth Mobilization- engage NYK and NSS, take No tobacco pledge on QR code
- · Awareness and Outreach through railies, events, marathons,
- Training and Capacity Building of youths as Tobacco Control Champions and Tobacco Ambassadors
- Promoting Healthy Lifestyles- by encouraging youth clubs to include the "Health and fitness without Tobacco" theme in the local events.
- Collaboration with Health, Education and Tribal Development Department for widespread act of TFYC 3.0 and Monitoring of engagement level of youth organization in the campaign

16. Role of Information and Public Relation Department

- · Awareness and Communication Strategy
- · Media Coordination and Outreach
- · Public Engagement and Behavioral Change Promotion
- · Collaboration and Inter-departmental Coordination

17. Role of NGOs/FBO

- · Raising public awareness and education about harmful effects of tobacco
- Community engagement, especially youth and vulnerable populations, to promote tobacco prevention and cessation.
- Monitoring implementation of COTPA, PECA, TVL in the jurisdiction.
- · Identify violations and report to the authorities
- Providing support to those affected by tobacco use

In her concluding remarks, the Chairperson reaffirmed the State Government's steadfast commitment to sustaining Himachal Pradesh's leadership in tobacco contro programme. She called upon all departments and district administrations to maintain strict vigilance and enforcement of all tobacco control taws, ensuring zero tolerance toward violations, particularly. Hukkah bar, electronic cigarettes and sales of tobacco products to minors. The Chairperson further instructed that special emphasis be laid on intensifying enforcement drives, particularly targeting youth-related settings, and on the effective implementation of the Tobacco Free Youth Campaign 3.0 across all districts.

She particularly requested the Department of Urban Development and Panchayati Raj to implement the tobacco vendor's licensing as per the Act. She also emphasized that interdepartmental coordination be strengthened at every level and a weekly performance reviews be conducted by the Deputy Commissioners. The Chairperson emphasized that timely reporting must be ensured. She concluded by expressing confidence that with collective commitment, rigorous enforcement and sustained efforts our state will continue to serve as a model State for tobacco control in the country.

The meeting concluded with a vote of thanks to the Chair.




