**ORDER**


In the matter of:- CWP No. 17645/2025-titled as Sanjeev Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 17645 of 2025 in the Hon'ble High Court vide which sought his transfer from GHS Balahra u/c GSSS Lahru Distt. Kangra HP to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on 13.11.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 22-12-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Sanjeev Kumar, TGT (Arts), submitted fresh representation and stated that he is working at GHS Balahra u/c GSSS Lahru Distt. Kangra and requested for transfer/adjustment at either at GMS Dimmi u/c GSSS Tikkar Khatrian, GSSS Chamboh, GMS Ropa u/c GSSS Kakriar, GSSS Bagwara Distt Hamirpur or anywhere in Distt. Hamirpur on account of completion of normal tenure as well as on couple case basis as his wife is also working in the Education Department and having old age widow mother.

From the perusal of the record, it is found that Sh. Sanjeev Kumar, TGT (Arts), is posted at GHS Balahra u/c GSSS Lahru Distt. Kangra since 08.7.2021, he has completed his normal tenure at present place of posting. Further the institution GHS Balahra, is situated in a soft area of district Kangra, wherein about 21 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right."

Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner (Sh. Sanjeev Kumar, TGT (Arts)) is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GHS Balahra Distt. Kangra. It is further considered that the transfer of the petitioner at this stage would adversely affect the studies of the students during the mid-academic session. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.

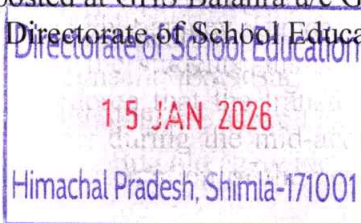
