ORDER

Whereas, Sh. Dinesh Kumar, DPE/Lect. Physical Education presently posted at GSSS Ropa (Mandi) (Hard Area) w.e.f. 14.07.2021 has filed CWP No. 19347/2025 before the Hon'ble High Court regarding to direct the respondent to decide his pending representation wherein he has seeking his transfer from GSSS Ropa (Mandi) to his choice of station i.e. GSSS Padhar /GSSS Urla/ GSSS Dhar Dist. Mandi against longer stayee, as he has completed his normal tenure in hard area as well as his mother is 80 years old and also suffering from several old age related ailment.

The case was listed before the Hon'ble Court on 09.12.2025 when the case was disposed of with the following directions:-

Since it is quite apparent from the pleadings adduced on record in the petition, which is duly supported by an affidavit, that petitioner has already completed more than normal tenure in hard area coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer from hard/difficult area to soft area or one of the stations of his/her choice after completion of normal tenure of posting i.e. three summers and two winters, this court sees no impediment in issuing direction to the respondents to consider and decide pending representation of the petitioner, expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of transfer policy. Pending applications, if any, also stand disposed of."

And whereas, to settle the said court case petitioner was called for personal hearing on 16.01.2026. **During the course of hearing petitioner has informed that presently he is posted in hard area i.e. GSSS Ropa (MND) which is 31 kms away from his native place but he has completed his normal tenure there as well as his mother is around 80 years old and he is the only one to look after her. And further requested that keeping in view of his grievances he may kindly be transfer to one of the station of his choice.**


And whereas, while examined the matter it is found that petitioner is posted within 31 kms from his native place as stated by the petitioner during the course of hearing and which stations has sought by him is not lying vacant or incumbents who is working GSSS Padhar (MND) and GSSS Urla (Mandi) has already served in hard area and incumbent who is working in GSSS Dhar (MND) is a female teacher and the **petitioner is working as DPE which is state cadre and presently he is just 31 Km from his native place.**

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected.

With these observations, representation stands disposed of.
