

Whereas, Sh. Jeevan Kumar, TGT(NM) previously working in GSSS Saloh Beri, Distt. Una has filed CWPNo.9471/2025 titled as Sh.Jeevan Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be adjusted to one of the stations of his choice in Distt. Chamba. The case of the petitioner was listed before the Hon'ble High Court on 06.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Since petitioner has already completed normal tenure of posting at present station, issue raised with regard to D.O. note issued by some local MLA may not be of much relevance. Transfer Policy, formulated by the Government of Himachal Pradesh, clearly provides tenure of three years of an employee at a particular station. Once petitioner has already completed normal tenure of posting at present station, no illegality can be said to have been committed by the respondents while passing impugned transfer order, however, having taken note of adverse family circumstances of the petitioner, as came to be apprised to this Court during the proceedings of the case, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation before the competent authority praying therein for cancellation of transfer order or adjustment at a convenient station, within a period of two days, which in-turn shall be decided by the afore authority expeditiously, preferably, within a period of one week. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of transfer policy, as taken note hereinabove. Till the time, representation, if filed within two days, is not decided in terms of instant order, petitioner shall not be compelled to join at the transferred station."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 23.06.2025 and 3.7.2025 but the petitioner did not appear. The petitioner has submitted his representation therein stating that he may adjusted at GMS Lothal u/c GHS Choori, Distt. Chamba.
