ORDER

Sh. Ashwani Thakur, JBT has filed CWP No. 17935/2025 before the Hon'ble High Court for his transfer. The case was listed before the Hon'ble High Court on 19.12.2025, when the same was disposed of with following order.

"Since it is quite apparent from the pleadings adduced on record in the petition, which is duly supported by an affidavit, that petitioner has already completed normal tenure in hard coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer from hard/tribal area to soft area or one of the stations of his/her choice after completion of normal tenure of posting i.e. three summers and two winters, this court sees no impediment in issuing direction to the respondents to consider and decide pending representation of the petitioner, expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of transfer policy. Pending applications, if any, also stand disposed of."

In compliance of the above direction of the Hon'ble High Court, the petitioner was called for perusal hearing on 15.12.2025 when the representation submitted by the petitioner has examined in detailed. On the perusal of comments submitted by the DDEE Chamba, it is revealed that the petitioner Sh. Ashwani Thakur, JBT has been working at GPS Bhamal, EB Gehra, Distt. Chamba at hard area, since 28.09.2022 as JBT on contract basis. The petitioner has requested for his transfer from GPS Bhamal, Gehra, Distt. Chamba to one of the vacant stations of his choice i.e. (1) GPS Rang (2) GPS Delag (3) GPS Purkhada (4) GPS Draman (5) Awan, EB Chowari, Distt. Chamba, HP. Against vacancy.

In view of above facts, the representation of the petitioner is examined sympathetically after due consideration. Due to his adverse family circumstances representation of Sh. Ashwani Thakur, JBT, dated on 15.11.2025, has been examined and after due consideration the Deputy Director of School (Ele.) Education, Chamba is hereby directed that the petitioner Sh. Ashwani Thakur, JBT, may be transferred from GPS Bhamal, E/B Gehra to GPS Rang, EB Chowari, Distt. Chamba, H.P. against vacant post where enrolment is 28 and without teacher school. Hence, the representation of the petitioner stands decided and disposed off accordingly.
