ORDER.

The Petitioner Smt. Reena Dhiman, TGT(Med) filed CWP No. 12090/2025

titled as, Smt. Reena Dhiman, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GHS, Jhunga u/c GSSS Lambagaon Distt. (Kangra.) to GSSS, Harchakiyan/GSSS Bankhandi/GSSS, Dehan/GSSS, Khalet/GSSS, Banuri/GSSS Par, District Kangra. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 28.07.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Petitioner is serving as Trained Graduate Teacher (Medical) at Government High School Jhunga u/c GSSS Lambagaon District Kangra, H.P. Her grievance is that on completion of requisite tenure at the aforesaid place, which falls under most difficult areas category, she preferred a representation on 01.06.2025 (Annecure P-1) to respondent No.2, seeking transfer to her preferred stations, however, the said representation till date has not been decided by the aforesaid respondent/competent authority.

Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law and applicable transfer policy, within a period of four weeks from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(S), if any, shall also stand disposed of."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 25.08.2025, 03.09.2025 and on 15.09.2025 with the fresh representation. But did not attend any of them. In Annexure P-1 she has requested to adjust her at GSSS, Harchakiyan/GSSS Bankhandi/GSSS, Dehan/GSSS, Khalet/GSSS, Banuri/GSSS Par, District Kangra.

After perusal of the relevant record, it is revealed that the petitioner has been working in GHS, Jhunga u/c GSSS, Lambagaon Distt. (Kangra) since 30.5.2022 which is a soft area and she has completed her normal tenure at her present place of posting. The petitioner being TGT (Med.) and a State cadre post holder, she can be posted anywhere in the state as per requirement. However, since she is already serving within her home district Kangra. The petitioner in her representation has specified for his adjustment in GSSS, Harchakiyan/GSSS Bankhandi/GSSS, Dehan/GSSS, Khalet/GSSS, Banuri/GSSS Par, District Kangra. Furthermore, At present, vacancies are not available in the above-mentioned schools where petitioner requested for transfer, hence the request of the petioner cannot be acceded. The representation of the petitioner is disposed of after due consideration.
