Above court case was listed before the Hon'ble High Court on 18.06.2025 when the Hon'ble Court has disposed of the same.

## That the petitioner in the present writ petition was praying for following relief:-

- "i) That writ of mandamus may kindly be issued, directing the respondent authorities to consider the petitioners being TGT (Arts) for all intents and purposes in light of the ratio laid down by this Hon'ble Court vide dated 04.09.2023 passed in CWP No. 2171/2023, titled as Hem Raj & connected matters (Annexure P-11), since the respondent department has already treated one set of C&Vs (Hindi & Sanskrit) as TGTs and in view of the above mentioned judgment of Hem Raj, the said set of TGTs have been given all benefits qua the post of TGT(Arts).
- ii) That writ of mandamus may kindly be issued, directing the respondent authorities to grant the pay scale of TGT (Arts) to the petitioners in view of the ratio laid down by this Hon'ble Court vide dated 04,09.2023 passed in CWP No. 2171/2023, titled as Hem Raj & connected matters (Annexure P-11) iii) That writ of mandamus may kindly be issued, directing the respondent authorities to consider the petitioners TGTs for promotion to the post of Lecturer (School New) & Head master."

## Operative part of the judgment dated 18.06.2025 passed in CWP 8253/2023 is as

## under:-

- 2. Though by way of filing reply, claim put forth by the petitioners has been refuted by the respondents, but before case at hand could be heard and decided on its own merits, learned counsel for the petitioners while referring to judgment dated 4.9.2023, passed in CWP No. 2171 of 2023, titled Hem Raj & Ors v. State of Himachal Pradesh alongwith connected matters, states that issue sought to be decided in the instant proceedings stands adjudicated in the afore judgment and as such, petitioners would be content and satisfied in case directions are issued to the respondents to consider their case in light of afore judgment.
- 3. Learned Additional Advocate General is not averse to the aforesaid innocuous prayer made by the learned counsel for the petitioners
- 4. Having perused aforesaid judgment sought to be relied upon vis-à-vis issue raised in the petition at hand, this Court finds that issue raised in the instant petition already stands adjudicated in the aforesaid judgment rendered by coordinate Bench of this Court and as such, no prejudice would be caused to either of the parties in case respondents are directed to consider and decide case of the petitioners in light of the aforesaid judgment.
- 5. Consequently, in view of the above, present petition is disposed of with direction to the respondents to consider and decide case of the petitioners in light of Hem Raj (supra), expeditiously, preferably, within four weeks from today. In case, petitioners are found to be similarly situate to the petitioners in the aforesaid judgment, they

Needless to say, authority concerned while doing the needful in terms of the instant order shall afford an opportunity of hearing to the petitioners and pass speaking order thereupon taking note of the observations made herein above as well as findings returned in the afore judgment.

In compliance to the above decision the petitioners heard in person on dated 21.07.2025. And on perusal of the record it has found that the Government of Himachal Pradesh has issued notification dated 20.08.2022 and changed the nomenclature of B.Ed. qualified and TET passed Shastri and Language Teachers as TGT Sanskrit and TGT Hindi respectively in their own pay scale structure. Whereas, the petitioners were working as Urdu/Punjabi Language Teachers and these categories are not incorporated in the above notification. Hence, the benefit of the judgment dated 4.9.2023, passed in CWP No. 2171 of 2023, titled Hem Raj cannot be extended to the petitioners.

Hence, the representation of the petitioners is hereby considered and decided accordingly.
