In the matter of: CWP No. 266/2025- titled as Rajender Kumar (Shastri) Vs. State of H.P. and others.(Regarding transfer under 5% quota)

Whereas, Rajender Kumar (Shastri) presently working in GMS Mashu u/c GSSS Jamna District Sirmour, H.P. has filed CWP. No. 266/2025 titled as Rajendr Kumar, Vs. State of H.P. and others, regarding his transfer from GMS Mashu u/c GSSS Jamna, Distt. Sirmour to Distt. Shimla under 5% quota. The case of the petitioner was listed before the Hon'ble High Court on 05.01.2026, when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 11.09.2025 (Annexure P-1) in accordance with law, applicable transfer policy as well as notification dated 20.11.2021, within a period of six weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 03.02.2026. The petitioner appeared before the undersigned on schedule date and time. At the time of hearing he has requested that he may kindly be transferred from GMS Mashu u/c GSSS Jamna, Distt. Sirmour to Distt. Shimla against vacancy, under 5% quota inter district transfer policy.

From perusal of the record, it is revealed that Sh. Rajender Kumar, TGT, (Sanskrit) working in GMS Mashu u/c GSSS Jamna Distt. Sirmour since 20.08.2019. At present 435 post of shastri are sanctioned and out of these sanctioned about 36 post of shastri are lying vacant in District Sirmour, presently 26 students are studying in GMS Mashu u/c GSSS Jamna District Sirmour. It is also pertinent to mention here that C&V cadre is a District cadre post. Before appointment the candidates apply in the district, where probability of their selection is high. As and when they complete their tenure they approach the Hon'ble High Court. Moreover, the process of appointment of shastri is subjudice in the Hon'ble Apex Court.

Keeping in view the future of students, the representation of the petitioner to transfer him GMS Mashu u/c GSSS Jamna, Distt. Sirmour to Distt. Shimla under 5% quota cannot be considered at this stage. Keeping in view the position stated above, representation of the petitioner is considered and rejected accordingly.
