The case of the petitioner was listed before the Hon'ble High Court on 05.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

6. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass speaking order taking note of the Comprehensive Guiding Principles, which provides for adjustment of an employee, on account of adverse family circumstances. Till the time, representation, if filed within two days from today, is decided by afore respondent, petitioner shall not be relieved. Petition stands disposed of in afore terms, alongwith all pending applications.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 23.06.2025 but petitioner did not appear. However, another opportunity was granted to the petitioner on 03.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GMS Nangal Chowk u/c GSSS Dadasiba or GMS Dhaunta u/c GSSS Behin or GMS Bassi u/c GSSS Jambal Distt. Kangra, against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Balghar u/c GSSS Dadasiba, Distt. Kangra to GMS Lakhoti u/c GSSS Dubloo Distt. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

Whereas, Smt. Sushma Devi, TGT(NM) presently working in GMS Bohrar u/c GSSS Nerwa, Distt. Shimla has filed CWP. No.9081/2025 titled as Sushma Devi Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred at one of the stations of her choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 30.05.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWPs with the following directions/Order:-

"Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner (Annexure P-3 & P-6) expeditiously, preferably within a period of three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order taking note of Transfer, Policy, which enables an employee to seek transfer from hard area to soft area on account of his/her having complete normal tenure of posting i.e. two winters and three summers. Pending applications, if any, also stand disposed of".

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 20.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GMS Bohrar u/c GSSS Nerwa, Distt. Shimla to GSSS Seratuana or GSSS Kaned or GSSS Rakkar or GHS Sunehar or GSSS Baldher, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner has been working in GMS Bohrar u/c GSSS Nerwa, Distt. Shimla since 18.02.2021. Though the said teacher has completed her normal tenure of three years at her present place of posting but at present 21 students are studying there. Keeping in view the studies of the students studying at GMS Bohrar u/c GSSS Nerwa, Distt. Shimla, it shall not be feasible to transfer the petitioner because in the absence of TGT(NM) the studies of students, will be affected adversely. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration.

Whereas, Sh. Manjeet Singh Chandel, TGT(NM) previously working in GMS Lalyar u/c GSSS Samirpur, Distt. Hamirpur has filed CWP. No.7517/2025 titled as Manjeet Singh Chandel Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be retain at GMS Lalyar u/c GSSS Samirpur, Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 06.05.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWPs with the following directions/Order:-

"Having, heard learned counsel for the parties and perused material available on record, though this Court finds that petitioner has not completed normal tenure of posting at present place of posting, but since he remained posted in District Hamirpur for more than one decade, no illegality can be said to have been committed by the respondents, while passing impugned transfer order. However 2 High Court of H.P. having taken note of the fact that petitioner is due to retire within a period of less than two years and there is specific provision contained in the transfer policy that an employee having less than two years to retire shall be posted to one of the stations of his choice, this Court deems it fit to dispose of the present petition reserving liberty to the petitioner to file representation to the competent authority within a period of one week, praying therein for cancellation of transfer or adjustment at one of the stations of his choice, which in turn shall be decided by the competent authority within a period of two weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, besides affording opportunity of being heard to the petitioner, shall also take note of provision contained in Transfer Policy and pass appropriate orders. Till the time, representation, as detailed herein above, is not decided in terms of instant order, petitioner shall not be compelled to join at transferred station in terms of impugned transfer order. Pending applications, if any, stand disposed of".

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 20.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be retain

at GMS Lalyar u/c GSSS Samirpur, Distt. Hamirpur as he is on the verge of retirement.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Lalyar u/c GSSS Samirpur, Distt. Hamirpur to GSSS Darlaghat, Distt. Solan vice Sh. Amar Chand, TGT(NM) vide order dated 2.5.2025 with the prior approval of competent authority. GSSS Darlaghat falls in soft area. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration.
