## OFFICE ORDER

Whereas, Sh. Ashok Kumar, Lect./Lect.(SN) Pol.Science has filed CWP No. 10982/2025 before the Hon'ble High Court regarding seeking his transfer from GSSS Lohardi (Chhota Bhangal) (hard area) to his choice of station i.e. GSSS Saliana (Kangra) against vacancy, GSSS Banuri (KGR) /GSSS Ghar (KGR)/ GSSS (G) Palampur(KGR)/ GSSS Andretta(KGR) / GSSS Pahra (Kangra) against longer stayee as he is working in hard area in Distt Kangra, and completed his normal tenure and he is also on the verge of his retirement with in 8 months and his mother is suffering from Paralysis and except his wife there is no one to look after him as he is only son.

The case was listed before the Hon'ble Court on 09.07.2025 when the case was disposed of with the following directions:-

"Petitioner is serving as Lecturer (School New) Political Science at GSSS Lohardi (Chotta Bhangal), District Kangra. His grievance is that on completion of requisite tenure in terms of applicable transfer policy at the aforesaid station, stated to be hard and tribal area, he preferred a representation on 18.03.2025 (Annexure P-3) citing his adverse family circumstances to the respondents/Competent Authority seeking his transfer to a station of his choice, however, the aforesaid representation has not been decided till date.

Looking to the nature of the grievance raised in this writ petition, it would in the interest of justice to direct Competent Authority to consider and decide the aforesaid representation dated 18.03.2025 (Annexure P-3) of the petitioner in accordance with law and as per applicable policy within a period of three weeks from today. Ordered accordingly. The order so passed be also communicated to the petitioner. The writ petition stands disposed of in the above terms. All pending miscellaneous application(s), if any, toalso stand disposed of"

And whereas, to settle the said court case petitioner was called for personal hearing on 09.09.2025. During the course of hearing petitioner has submitted his fresh representation wherein he has requested that he is completed his normal tenure in hard area and he is also on the verge of retirement within 8 months and his mother is suffering from Paralysis and except his wife there is no one to look after him as he is only son and further requested that, keeping in view his adverse family circumstance he may kindly be adjusted either at GSSS Saliana (Kangra) against vacancy, GSSS Banuri (KGR) /GSSS Ghar (KGR)/ GSSS (G) Palampur(KGR)/ GSSS Andretta(KGR) / GSSS Pahra (Kangra) against longer stayee.

And whereas, that the matter has been examined and found that at present post is not lying vacant at proposed stations as such all incumbents having short stay except incumbent posted at GSSS Andretta (KGR) as he has completed his normal tenure and never served in tribal/hard area. Now he is liable to serve in hard area as per transfer policy.

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and petitioner i.e. Sh. Ashok Kumar, Lect./Lect.(SN) Pol.Science, who is posted at GSSS Lohardi (KGR) is hereby transferred to GSSS Andretta (KGR), without TTA/JT vice Sh.Satish Kumar, Lect./Lect.(SN) Pol.Science and vice versa with TTA/JT.

With these observations, representation stands disposed of.
