

OFFICE ORDER

In the matter of:

CWP No. 20010/2025-titled as Jamana Thakur, Vs. State of H.P & Others.

Whereas, Smt. Jamana Thakur, Lect. Chemistry preferred CWP No. 20010/2025 titled as Jamana Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Chowai, Distt. Kullu to GSSS(Girls) Palampur, Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 18-12-2025 when the Hon'ble High Court has passed the following orders:-

4. " *In view of above, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide petitioner's representation dated 06.10.2025 (Annexure P-2), in accordance with law, as per applicable transfer policy and keeping in view Tarjeet Kumar2 within a period of four weeks from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, also stands disposed of."*

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 29-12-2025. She attended the same and submitted her representation in this office on 29-12-2025, vide which She has requested that She may be transferred from GSSS Chowai, Distt. Kullu, H.P to GSSS(Girls) Palampur, Distt. Kangra, H.P, against vacancy being caused due to retirement of present incumbent on 31-12-2025.

In the perusal of the record, it is found that the petitioner is working at GSSS Chowai, Distt. Kullu, H.P since 13-13-2024. One post of Lect. Chemistry is going to be vacant due to retirement of present incumbent at GSSS (Girls) Palampur, Distt. Kangra on 31-12-2025. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and She is hereby transferred without TTA/JT from GSSS Chowai, Distt. Kullu, H.P. to GSSS (Girls) Palampur, Distt. Kangra, against vacancy likely to be caused due to retirement of present incumbent 31.12.2025. These orders will be implemented after the retirement of present incumbent on 31.12.2025. The representation of the petitioner is disposed of accordingly.
