ORDER

Whereas, the petitioner namely Sh.Raj Kumar Sharma, Headmaster who is under transfer from GSSS GHS Raipur Sahoran (Una) to GHS Anji Banona (Smr), he has filed CWP No. 9641/2025 titled as Raj Kumar Sharma vs State of HP before the Hon'ble High Court seeking therein relief regarding his adjustment due to his adverse family circumstances. This petition was listed on 11.06.2025 when the Hon'ble Court has given following directions:-

Leaving all questions open and in view of the prayer made by Learned Counsel for petitioner, the instant petition is disposed of at this stage, in the following terms:

(i). Respondent No.2-Director, Higher Education, Government of Himachal Pradesh is directed to examine/ consider the representation [Annexure P-2] in accordance with Transfer Policy and the applicable law after hearing the petitioner and Respondent No.3 [Yograj] on or before 24.06.2025;

(ii). Petitioner is permitted to make additional representation, if any, within two days from today, which shall also be examined/considered by the Competent Authority;

(iii). However, in order to safeguard, the rights/interests of parties herein, this Court directs that respondents shall not compet the petitioner to join the transferred station [GHS Anji Banona] till decision of representation(s); and the petitioner is free to evail leave of kind due;

(iv). No order as to costs.

In aforesaid terms, the instant petition and all pending miscellaneous application(s), if any, shall also stand disposed of.

And whereas, in compliance of Hon'ble High Court order dated 11.06.2025 the petitioner was called for personal hearing on 30.06.2025 and he was heard in person. During the course of hearing and in his representation dated 18.06.2025 he has requested that he may be adjusted at DDE Una (Quality Control against the post of Principal.

And whereas, as per direction passed by the Hon'ble High Court as above, the request of the petitioner has been examined and considered against the pest of Principal (Quality Control) in the o/o DDE Una.

Now therefore, after taking into account the above discussed detailed facts and circumstances, representation has been considered and allowed. The petitioner i.e Sh.Raj Kumar Sharma, Headmaster who is under transfer from GHS Raipur Sahoran (Una) to GHS Anji Banona (Smr) is hereby adjusted at DDE Una against the post of Principal (Quality Control). Hence representation stands disposed of.

May inform the parties accordingly.

ORDER

Whereas, Sh. Hukam Chand Bhardwaj, Lecturer (School-New) (Economics) was filed CWP No. 9233/2025 before the Hon'ble High Court against his transfer issued vide this office order dated 28.5.2025 as pleaded that his father is unwell and requires constant care.

The case was listed before the Hon'ble Court on 03.06.2025 when the case was disposed of with the following directions:-

"Though having taken note of the fact that petitioner already completed normal tenure of posting at present place of posting and distance between the transferred station and the present place of posting is not more than 25 Kms, this Court sees no reason to interfere in the impugned transfer order and as such, same is upheld. However having taken note of the fact that father of the petitioner is unwell and requires constant care of his son, this Court deems it fit to disposed of the present petition reserving liberty to the petitioner to file representation to the competent authority within a period of one week seeking adjustment at a convenient station, which shall be decided by the competent authority within one week. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer policy, which enables the employee to seek trasfner/adjustment at a convenient station on account of adverse family circumstances. Till the time representation as detailed herein above, is not decided in terms of instant order, petitioner shall not be compelled to join at transferred station in terms of impugued transfer order. Pending application if any, stand disposed of".

And whereas, as per the direction passed by the Hon'ble High Court on 14.5.2025, petitioner was called to appear in person on dated 24.6.2025 & 30.6.2025. During the course of hearing, petitioner has informed that although he has joined at GSSS Neether on 13.6.2025 but he has further requested that if possible to transfer him to GSSS Tebban (MND) vice Sh. Devinder Verma, Lecturer (School-New) (Economics) on mutual consent basis as stay of Devinder Verma is complete being medical problems of his father as he is suffering from Orthopedic disorder (both legs fractured) and he is under treatment from IGMC Shimla since April 2025 so he is unable to walk and he has to be carried even to urinate and defecate.

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and petitioner i.e. Sh. Hukam Chand Bhardwaj, Lecturer (School-New) (Economics) is being transferred from GSSS Neether (KLU) in condoantion of short stay to GSSS Tebban (MND) vice Sh. Devinder Verma, Lecturer (School-New) (Economics) & vice versa on mutual consent basis on medical grounds of petitioner's father without TTA/JT of both as per mutual consent of both.

Note: Both the Principals may ensure mutual consent of both the officials before relieving/joining

With these observations, representation stands disposed of.

OFFICE ORDER

Whereas, Sh. Harbans Kumar, Lect./Lect.(SN) Pol. Science who is under orders of transfer from GSSS Dadasiba (KGR) to GSSS Bagheigarh (CBA) against vacancy, with TTA/JT to sattle the CWPIL 28/2024 vide this office order dated 28.04.2025, But against these orders Harbans Kumar, Lect./Lect.(SN) Pol. Science has filed CWP No.7821/2025 before the Hon'ble High Courts

The case was listed before Hon'ble High Court on 13.05.2025 when the case was disposed of with the following directions:-

"Consequently, in view of the above, this court without going into the merits of the ace, deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation of the competent authority within a period of one week, praying therein for cancellation of his transfer order, which in turn, shall be decided by the competent authority within a period of two weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate oder taking note of observation made hereinabove as well as very object and intent of transfer policy as indicated hereinabove, Till the time representation, if any filed by the petitioner with in of one week is not decided y the competent authority, petitioner shall not be compelled to join at the transferred station. Pending application if any also stand disposed of."

And whereas, upon passing of above directions, petitioner was called for personal hearing on dated 20.6.2025. During the course of hearing, petitioner has requested that he has already served in sub cadre area i.e. GSSS Kupvi (Shimla) w.e.f. 30.3.2001 to 30.12.2006 as TGT and again he has been transferred to GSSS Bagheigarh (Chamba) which is also a hard area hence, he may be adjusted either at GSSS Pohanj (HMR), GSSS Taunidevi (HMR), GSSS Jangal Beri (HMR), GSSS Bankhandi (KGR) or GSSS Bajrol (HMR).

And whereas, while examining his representation it is found that the petitioner was transferred from GSSS Dadasiba(Kangra) as the post of Lecturer Pol.Science at GSSS Dadasiba(Kangra) has become surplus due to low enrolment of students. Moreover, he was transferred to GSSS Bagheigarh (CBA) in the interest of poor students who is studying in Kasturba Gandhi Balika Vidyalaya (KGBV) (Hostel) Bhageigarh (Chamba) and as well as to sattle the pending CWPIL No. 28/2024 titled as Vipin Kumar vs State vide which Hon'ble High Court has directed to respondent- State/Department to pass appropriate order for posting of teaching & non-teaching staff at GSSS Bagheigarh, Distt. Chamba and also submit fresh status report with respect to joining of the persons/employee posted/transferred to the posts concerned. And the petitioner has serving at GSSS Dadasiba (KGR) since 2015 and completed almost 10 years in the same station.

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and his transfer orders dated 28.04.2025 shall stand.

With these observations, representation stands disposed of.

OFFICE ORDER

Whereas, Sh. Subhash Chand, Lect./Lect.(SN) Pol. Science who is under orders of transfer from GSSS (B) Pragpur (KGR) to GSSS Mail (Chamba) against vacancy by clubbing his previous stay within the radius of 30 Kms, with TTA/JT vide this office order dated 04.06.2025 with the prior approval of competent authority. But, Sh Subhash Chand, Lect./Lect.(SN) Pol. Science has filed CWP No.10101/2025 before the Hon'ble High Court against this transfer orders. The case was listed before Hon'ble High Court on 28.03.2025 when the case was disposed of with the following directions:-

"For the reasons stated hereinabove, though, this Court sees no reason to interfere with the impugned transfer order, however having taken note of the fact that he has approached the competent authority by way of representation dated 12.06.2025(Annexure P-3) for cancellation of transfer order/adjustment at a convenient station on the ground of adverse family circumstances as well as couple case, this Court without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the representation dated 12.06.2025(Annexure P-3) of the petitioner expeditiously, preferably within a period of ten days. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of transfer policy framed by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer/adjustment on the ground of couple case as well as adverse family circumstances. Till the time representation, if any, filed by the petitioner is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."

And whereas, upon passing of above directions, As per direction of Hon'ble High Court, petitioner has submitted his representation on dated 27.06.2025 and requested that due to his adverse family circumstances he is not able to join at transferred station as as his mother is suffering from spinal problem and there is no one to look after her except me. Hence he may be adjusted at GSSS Dhaliara (KGR)/GSSS Behin (KGR) GSSS Kharian (KGR)/GSSS Bankhandi (KGR)/GSSS Andoura (UNA) against vacancy keeping in view of his adverse family circumstances and also being a couple case.

And whereas, as per direction passed by the Hon'ble High Court as above, while examined his representation it is found that petitioner is serving within the radius of 30 Kms since 6 years and has been transferred to GSSS Mail (CBA) against vacancy which is a soft area with the prior approval of competent authority. However, as per "Comprehensive Guiding Principles- 2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and his transfer orders dated 04.06.2025 shall stand.

With these observations, representation stands disposed of.
