Whereas, Karmveer Singh, TGT (NM) preferred CWP No. 4494/2025 titled as Karmveer Singh, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Manhota, U/C GMSSS Mehla, Distt. Chamba, H.P. to nearby his native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27-03-2025 when the Hon'ble High Court has passed the following orders:-

3. "Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 03-03-2025, in accordance with law and applicable Transfer Policy, within a period of six weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 26-04-2025. He attended the same and submitted his representation in this office on 26-04-2025, vide which He has requested that He may be transfer from GMS Manhota, U/C GMSSS Mehla, Distt. Chamba, H.P to nearby his native place in district Kangra, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms. .

From perusal of record, it has been found that the petitioner has been working at GMS Manhota, U/C GMSSS Mehla, Distt. Chamba, H.P. (difficult Area) since 25-02-2022 and has completed his normal tenure at present place of posting. One Sh. Praveen Kumar, TGT(NM) is working in GMS Puhara, U/C GSSS Shahpur, Distt. Kangra, H.P. since 23-07-2022 and has almost completed three years stay there. The petitioner has given willingness for his transfer to the aforesaid school against longer stay/ longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and He is hereby transfer from GMS Manhota, U/C GMSSS Mehla, Distt. Chamba, H.P. to GMS Puhara, U/C GSSS Shahpur, Distt. Kangra, H.P. vice Sh. Praveen Kumar, TGT(NM) against longer stay, with TTA/JT to Sh. Praveen Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
