## ORDER

In the matter of:

CWP No. 10905/2025 titled as Tapsya Devi, TGT (NM) Vs. State of H.P. & others

Whereas, Smt. Tapsya Devi, TGT (NM) presently working in GMS Kartoo u/c Deothi Majhgaon, Distt. Sirmaur has filed CWP No. 10905/2025 titled as Tapsya Devi, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that she may be transferred form GMS Kartoo u/c Deothi Majhgaon, Distt. Sirmaur to one of the stations of her choice in Distt. Una. The case of the petitioner was listed before the Hon'ble High Court on 08.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

3. Since Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer on the ground of adverse family circumstances, coupled with the fact that petitioner, on account of her posting in District Sirmaur, is unable to take care of her ailing parents-in-law and children, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner (Annexure P-3) expeditiously, preferably within a period of three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy, which certainly enables an employee to seek transfer on account of adverse family circumstances. Needless to say, petitioner, if required, may also submit new representation to the competent authority at the time of personal hearing, indicating therein the name of schools in District Una, where she can be accommodated. Pending application(s), if any, stand disposed of.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 18.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GMS Kartoo u/c Deothi Majhgaon, Distf. Sirmaur to GMS Lower Panjawar or GSSS Oel or GMS Nagrwala u/c GSSS Jadla or GSSS Kuthera jaswala or GSSS Badhehra Rajputan or GSSS Daulatpur Chowk or GSSS Basdehra, Distf. Una against vacancy being caused due to retirement of present incumbent or against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working GMS Kartoo u/c Deothi Majhgaon, Distt. Sirmaur since 18.02.2022 and has completed there her normal tenure of three years. At present, one post of TGT (NM) is going to be vacant at GSSS Basdehra, Distt. Una on 31.08.2025 due to retirement of present incumbent.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby transferred from GMS Kartoo u/c Deothi Majhgaon, Distt. Sirmaur without TTA/JT to GSSS Basdehra, Distt. Una against vacancy being caused due to retirement of present incumbent on 31.08.2025, on her own request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
