Whereas, Ranjna Kumari, TGT (NM) presently working in GHS Kanda u/c GSSS Halau, Distt. Shimla has filed CWP. No. 13979/2025- titled as Ranjna Kumari, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that she may be transferred from GHS Kanda u/c GSSS Halau, Distt. Shimla to one of the station at her choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 30.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"3. Since it is quite apparent from the pleadings adduced on record by the petitioner that she has been working at present place of posting for more than three years, coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh provides for minimum tenure of three years at one station, this Court sees no impediment in issuing direction to the respondents to consider and decide the her representation expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note transfer policy, which enables an employee to seek transfer on account of adverse family circumstances.

4. Since stations indicated in the representation is stated to have been filled up, petitioner would be at liberty to file fresh representation on the date of hearing given by the authority concerned in terms of instant order, enabling competent authority to do the needful. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 25.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferrd from GHS Kanda u/c GSSS Halau, Distt. Shimla to GSSS Bajrol or GMS beri u/c GSSS Jangal Beri or GMS Lambri u/c GSSS Patlander or GHS Banal, Distt. Hamirpur against vacancy.

From the perusal of record, it is found that Smt. Ranjna TGT (NM) has been working at GHS Kanda u/c GSSS Halau, Distt. Shimla since 28.02.2022. Though the said teacher has completed her normal tenure of three years at GHS Kanda u/c GSSS Halau but at present 17 students are studying there. GHS Kanda u/c GSSS Halau falls in soft area. Keeping in view the studies of the students studying at GHS Kanda u/c GSSS Halau, Distt. Shimla it shall not be feasible to transfer the petitioner because in the absence of TGT (NM) the studies of students, will be affected adversely. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.
