The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 02-06-2025 when the Hon'ble High Court has passed the following orders:-

"Consequently, in view of the above, present petition is disposed of with a direction to the respondents to consider and decide the representation (Annexure P-6) expeditiously, preferably within a period of two weeks. 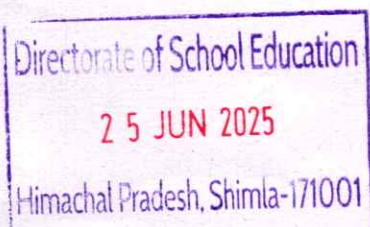

Whereas, Aman Singh, TGT (NM) preferred CWP No. 4129/2025 titled as Aman Singh, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Runpu, U/C GSSS Kinnu, Distt. Shimla, H.P to nearby his native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22-03-2025 when the Hon'ble High Court has passed the following orders:-

3. "Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while affording opportunity of hearing to the petitioner, shall also take note of the transfer policy formulated by the Government of Himachal Pradesh, which provides for transfer of an employee from hard/rural area to soft area after his/her having completed normal tenure at present place of posting and pass appropriate orders. Pending applications, if any, also stand disposed."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 26-04-2025. He attended the same and submitted his representation in this office on 26-04-2025, vide which He has requested that He may be transfer from Runpu, U/C GSSS Kinnu, Distt. Shimla, H.P to nearby his native place in Distt. Kangra, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms. .
