ORDER

Whereas, Smt. Anupama, Lecturer (School-New) Sanskrit was transferred from GBSSS Chamba (CBA) to GSSS Khajjiar (CBA) vide this office order of even number dated 02.06.2025 vice Sh. Pawan Kumar, Lecturer (School-New) Sanskirt and vice versa by clubbing her previous stay within the radius of 30 KMs. But against these orders Smt. Anupama, Lecturer (School-New) Sanskrit has filed CWP No. 9391/2025 before the Hon'ble Court. The case was listed before the the Hon'ble Court on 05.06.2025 when the Hon'ble High Court disposed of the case with the following directions:-

"Moreover, this Court finds that petitioner has been transferred at the distance of 20 KM. For the reasons detailed hereinabove, though this Court sees no reasone to interfere in the impugned transfer order, however having taken note of adverse family circumstances as came to be apprised to this Court during the proceedings of the case, this Court deems it fit to dispose of present petition, reserving liberty to the petitioner to file representation within two days to competent authority, praying therein for her adjustment at a convenient station, which in turn, shall be decided by the competent authority expeditiously, preferably within a period of one week, taking note of transfer policy, which certainly enables an employee to seek transfer/adjustment on the ground of adverse family circumstances. Till the time representation, if any, filed by the petitioner within a period of two days, is not decided by the competent authority, petitioner shall bot be compelled to join at the transferred station. Pending application, if any, also stand disposed of".

And whereas, upon passing of above directions, petitioner, Smt. Anupama, Lecturer (School-New) Sanskrit submitted a representation and requested either to adjust her at GGSSS Chamba (CBA) where post of Lecturer (Sanskrit) is going to fall vacant on 31.12.2025 or cancelled transfer order dated 02.06.2025 or adjusted under clause 5.4 of transfer policy keeping in view of her

adverse family circumstances.

And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that petitioner has already joined at transferred station i.e. GSSS Khajjiar (CBA) on 09.06.2025 as well as respondent i.e. Pawan Kumar has also joined at GBSSS Chamba hence her transfer order cannot be cancelled as it may lead another litigation. Moreover, petitioner has been transferred at the distance of 20 KM only and petitioner cannot be adjusted at GGSSS Chamba (CBA) at this early stage as the post of Lecturer (Sanskrit) will fall vacant on 31.12.2025.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stands disposed of.


