ORDER


Whereas, the petitioner namely Sh.Bhavneswar Lect(History) is working at GSSS Sudhar (Mnd) w.e.f 11.09.2019 and completed his normal stay and the school fall in sub cader area.. He has filed CWP No. 14353/2025 titled as Bhavneswar vs State of HP. This petition was listed on 05.09.2025 when the same was finally disposed with the directions to respondents as under:-

Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation (Annexure P-3) of the petitioner, expeditiously, preferably, within a period of three weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon. Pending application(s), if any, shall also stand disposed of.

And whereas, in compliance of Hon'ble High Court order dated 05.09.2025, the petitioner was called for personal hearing on 22.09.2025. During the course of hearing petitioner has requested that he may be adjusted at GSSS Matroo (Mnd) against vacancy or GSSS Gumma (Mnd)/ GSSS Harabag (Mnd)/ GSSS Urla (Mnd)/ GSSS Khuddar (Mnd)/ GSSS Bir (Kgr)/ GSSS Bassi (Mnd) against longer stay/clubbing his /her presious stay within radius of 30 Km .

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner has been considered and allowed. The petitioner i.e Sh.Bhavneswar Lect.(History) is being transfer from GSSS Sudhar (Mnd) to GSSS Matroo (Mnd) against vacancy as per his request. Hence representation stands disposed of.
