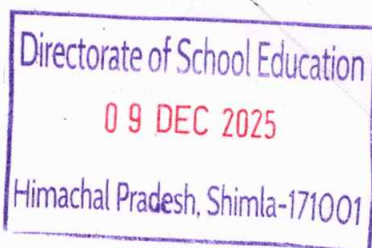




I am directed to refer to the subject cited above and to say that in response to this department's letter No. Fin(Pen)A(1)-1/2020 dated 08.03.2023, letter of even number dated 26.12.2023 and latest reminder dated 11.02.2025, the Administrative Secretaries and Head of Departments have furnished data of 2268 employees who were recruited against the posts/vacancies advertised/notified for recruitment on or before 15.05.2003.

In this regard, a meeting was held on 22.08.2025 under the chairmanship of Special Secretary (Finance) to the GoHP, with the Director, Treasuries, Accounts & Lotteries, HP and Senior Officers of the PAG(A&E) HP and the Finance Department. The data/information furnished by the AD's/HOD's on the subject matter was examined and discussed in the meeting and it was found that data/information furnished by the AD's/HOD's is incomplete and ambiguous. After detailed deliberation in the meeting, it was decided that the data/information received from AD's/HOD's may be re-validated by seeking accurate information on prescribed Performa, with details of PMIS No./PRAN No. etc. of the employees as per Annexure-'A'.

It is therefore requested that the correct information of employees who were recruited against the posts/vacancies advertised/notified for recruitment on or before 15.05.2003 in your department may be obtained from the subordinate offices and thereafter consolidated information be furnished to this department on the prescribed Performa at Annexure-'A', immediately.

This may be given top priority please.
