In the matter of: CWP No. 1839/2026- titled as Ram Singh, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Ram Singh, TGT(NM) presently working in GHS Jarai, Distt. Shimla has filed CWP No. 1839/2026 titled as Ram Singh Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Jarai, Distt. Shimla to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 16.02.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWPs with the following directions/Order :-

"Accordingly, this petition is disposed of with a direction to the respondents/authority to decide the representation of the petitioner dated 02.01.2026 (Annexure P-3) within a period of four weeks' from today by passing a speaking order and after giving an opportunity of being heard to the petitioner and the same shall be communicated to the petitioner. It is made clear that this Court has not expressed anything on the merits of the case, and the authority shall take a decision strictly in consonance with the provisions of law. Petition stands disposed of, so also the pending application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 05.03.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Jarai, Distt. Shimla to GSSS Jawali or GSSS Bhadal Thor, Distt. Kangra, against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working in GHS Jarai, Distt. Shimla, which falls under the soft area. The petitioner is a TGT(NM) which comes under State cadre post and can be posted anywhere in the state as per requirement. The petitioner in his representation has specified for his adjustment in GSSS Jawali or GSSS Badhal Thore, Distt. Kangra, against vacancy. However, as per Comprehensive Guidelines Principles-2013 there is no such provision that allows a government employee serving in soft area to specify stations of his choice for adjustment, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration.
