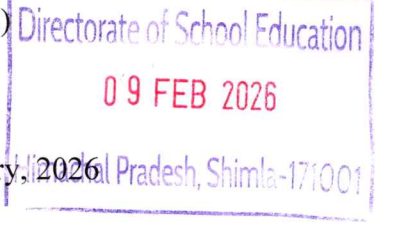

ORDER

Whereas, various petitioners have filed court case, in the Hon'ble High Court under CWP No. 15234 of 2025 titled as Parveen Kumar and another versus State of HP and others, CWP No. 16916 of 2025 titled as Mamta Kumari versus State of HP and others, CWP No. 17610 of 2025 titled as Manoj Kumar versus State of HP and others, CWP No. 17602 of 2025 titled as Krishna Devi versus State of HP and others, CWP No. 16658 of 2025 titled as Yadvender Kumar versus State of HP and others, CWP No. 16660 of 2025 titled as Chinta Mani versus State of HP and others, CWP No. 16662 of 2025 titled as Om Prakash versus State of HP and others, CWP No. 16666 of 2025 titled as Mamta versus State of HP and others, CWP No. 16853 of 2025 titled as Usha Devi and others versus State of HP and others, CWP No. 18178 of 2025 titled as Prem Prakash and others versus State of HP and others, CWP No. 18146 of 2025 titled as Anand Kumar and others versus State of HP and others, CWP No. 18148 of 2025 titled as Chuni Lal and another versus State of HP and others, CWP No. 18170 of 2025 titled as Ashok Kumar and another versus State of HP and others, CWP No. 16590 of 2025 titled as Bimla Devi and others versus State of HP and others, CWP No. 18604 of 2025 titled as Anita Kumari and others versus State of HP and others and CWP No. 20190 of 2025 titled as Rakhi Devi versus State of HP and others for want of relief that the applicants are squarely covered by the judgment dated 04.09.2023 passed by the Hon'ble High Court of HP in CWP No. 2171 of 2023 titled as Hem Raj and other versus State of HP, hence their case may kindly be considered for pay scale of TGTs as well as State Cadre in light of the above mentioned judgment.

Whereas, the Hon'ble High Court of HP has decided above court cases with the direction to the respondents/competent authority to consider and decide the representations of the petitioners, in accordance with law and as well as taking into consideration the judgment passed in CWP No. 2171 of 2023 titled as Hem Raj versus State of HP and others.

Whereas, the representation(s) of the petitioners have been examined in compliance to the judgment(s) passed by the Hon'ble Court and taking into consideration the Notification of the Government issued vide No. EDC-B(15)15/2011 dated 20-08-2022 which says, "all Bachelor of Education (B.Ed.) qualified and Teacher Eligibility Test (TET) passed Shastris and Language Teachers(LTs) are to be designated as Trained Graduate Teachers (Sanskrit) and Trained Graduate Teachers (Hindi) in their respective pay scale structure." Therefore, no financial benefits were granted to these categories, and merely their nomenclature was changed to TGT (Sanskrit) and TGT (Hindi) and that too for only those Shastri/Language Teachers who are B.Ed. qualified and TET pass.

Whereas, the matter of Sh. Hem Raj & others has already been examined at Govt. level in compliance to the judgment passed by the Hon'ble High Court in CWP No. 2171/2023 titled as Hem Raj vs. State of HP, CWP No. 8389/2023 to 8398 of 2023 alongwith all others connected matters and Execution Petition No. 168 & 170 of 2024 and thereafter the Govt. has passed detailed speaking orders on 20.05.2024 and subsequently addendum on

17.09.2024 vide which it has been clarified that these re-designated TGTs would be eligible for promotion to the post of Lecturer/Headmaster only after completion of the required length of service calculated from 20.08.2022 subject to the final outcome of LPA No. 86 of 2024 titled as State of HP versus Hem Raj.


Whereas, the Hon'ble High Court has stayed the operation of the judgment passed in CWP No. 2171/2023 titled as Hem Raj and others on 17.10.2025. The order passed by the Hon'ble Court in LPA No. 86 of 2024 is as under:-

"We stay the operation of judgment dated 04.09.2023 passed in CWP No.2171 of 2023 titled as Hem Raj and others vs. State of H.P and others to this extent, subject to completion of service".

Whereas, order passed by the Hon'ble High Court in aforementioned court cases relies upon the benefits granted in CWP No. 2171/2023 – Hem Raj, whose operation is presently stayed. The relief sought by the petitioner(s) is directly dependent upon the judgment dated 04.09.2023 in CWP No. 2171/2023, which is presently under stay by the Hon'ble High Court in LPA No. 86 of 2024 vide order dated 17.10.2025.

Therefore, after considering the whole matter, the claim of the petitioner in aforementioned court case(s) cannot be considered at this stage and shall be decided only after the final outcome of LPA No. 86 of 2024.

Inform all the concerned accordingly.

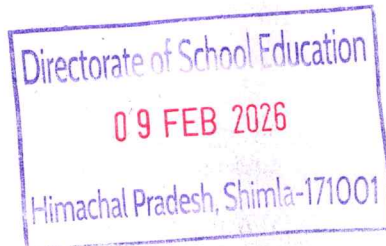
