In the matter of: CWP No. 10979/2025- titled as Manu Lata, Vs. State of H.P.
and others.

Whereas, Manu Lata, TGT (NM) presently working in GSSS Dadahu, Distt. Sirmour has filed CWP. No. 10979/2025- titled as Manu Lata, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that she may be transferred from GSSS Dadahu, Distt. Sirmour to one of the stations of his choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 09.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"5. Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation (Annexure P-2) of the petitioner, expeditiously, preferably, within a period of two weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order thereupon taking note of Transfer Policy, formulated by the Government of Himachal Pradesh, relevant provisions whereof have been already taken note hereinabove. In the aforesaid terms, present petition is disposed of along with pending application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 11.08.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GSSS Dadahu, Distt. Sirmour to GMS Nara u/c GSSS garli or GMS Jyoli Devi u/c GSSS Jode Amb or GMS Chambeh u/c GSSS Gyargraan or GMS Kamlheri u/c GSSS Gyargraan or GMS Nara u/c GSSS Garli or GMS Chambeh u/c GSSS Gyargraan GMS Kadsai u/c GSSS Jode Amb, Distt. Hamirpur against longer stayee or against vacancy being caused due to promotion of TGTs.

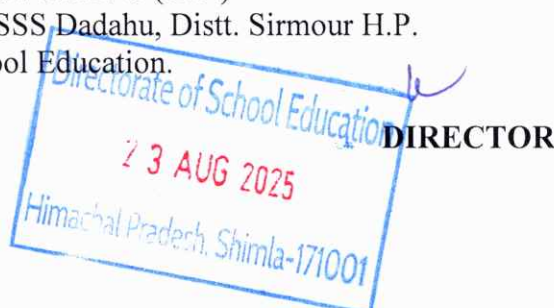
After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Dadahu, Distt. Sirmour since 02.07.2019. GSSS Dadahu falls in soft area. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

ORDER

In the matter of: CWP No. 10457/2025- Sh. Ashok Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Ashok Kumar, TGT(NM) previously working in GSSS Kashmaila, Distt. Mandi has filed CWP No. 10457/2025 titled as Sh. Ashok Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be adjusted to one of the stations of his choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 01.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

“ Having carefully perused the averments contained in the petition, this Court finds that the petitioner has completed normal tenure of posting at the present place of posting. The factum of issuance of DO note, if any, is of no consequences. Moreover impugned order nowhere suggests the same has been issued on the basis of DO note. Though the petitioner can be posted anywhere in the State, however, taking note of the fact that the wife of the petitioner is also working in the same Department in District Mandi, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority, praying therein for his adjustment at a convenient station, within a period of two weeks, which in-turn, shall be decided by the afore authority, expeditiously, preferably, within a period of two weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of Transfer Policy, which certainly enables an employee to seek posting at a convenient station, on account of couple case and adverse family circumstances. Till the time, representation, if filed within a period of two weeks is not decided, petitioner shall not be compelled to join at transferred station.

The present petition is disposed in the above terms, so also the pending miscellaneous application(s), if any .”

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 11.08.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GSSS Mundkhar or GSSS Bhukkar or GSSS Bhareri or GSSS Manoh, Distt. Hamirpur.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GSSS Kashmaila, Distt. Mandi to GSSS Deothi, Distt. Solan vide this Directorate letter of even number dated 4.6.2025 with the prior approval of competent authority. As per information received in this office, the petitioner Sh. Ashok Kumar, TGT(NM) has joined at the place of his posting in GSSS Deothi, Distt. Solan on 13.06.2025 and having short stay. Therefore, keeping in view of position stated above the representation made by the petitioner is not acceded to. The representation is disposed of accordingly.
