ORDER

In the matter of: CWP No. 13865/2025- Sh. Rajeev Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Rajeev Kumar, TGT(NM) presently working in GMS Kando Cheyog u/c GSSS Jamna, Distt. Sirmour has filed CWP No.13865/2025 titled as Rajeev Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 28.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Since it is not in dispute that on account of promotions of few teachers to the post of Lecturers/Head Masters, vacancies have arisen, this Court, deems it fit to dispose of the present petition reserving liberty to the petitioner to file fresh representation to the competent authority within three days, indicating therein vacant stations/longer stayee, which shall be decided by the competent authority within ten days from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of observations made hereinabove as well as Clause 5.4 of Transfer Policy, which enables an employee to seek transfer from one station to another on the ground of couple case. Pending applications, if any, stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 15.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Kando Cheyog u/c GSSS Jamna, Distt. Sirmour to GSSS Barot or GSSS Gangath or GSSS Hauri Devi or GSSS Pogruyan or GSSS Sehwan or GSSS Bhalaad or GMS Kalduyan or GHS Haryan or GSSS Chalwara, Distt. Kangra against vacancy/longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working in GMS Kando Cheyog u/c GSSS Jamna, Distt. Sirmour since 24.02.2021 on regular basis and has completed his normal tenure of three years. At present, one post of TGT(NM) is lying vacant at GSSS Hauri Devi Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Kando Cheyog u/c GSSS Jamna, Distt. Sirmour to GSSS Hauri Devi, Distt. Kangra, against vacancy without TTA/JT as per his request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
