ORDER

Whereas, Sh. Bhim Raj Chauhan, TGT(NM) presently working in GSSS Kujji, Distt. Sirmour has filed CWPNo.17380/2025 titled as Sh. Bhim Raj Chauhan Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Kujji, Distt. Sirmour to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 07.11.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner (Annexure P-3) in accordance with law and applicable transfer policy, within a period of three weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.11.2025 but he did not appear, however he has submitted a representation on 19.11.2025 through Counsel stating therein that his wife is suffering from cancer and also requested that he may be transferred from GSSS Kujji, Distt. Sirmour to GHS Bandahu u/c GSSS Paplag, Distt. Kangra, against vacancy.

After perusal of relevant record, it is revealed that the petitioner has been working in GSSS, Kujji, Distt. Sirmour since 30.07.2025. At present, one post of TGT(NM) is lying vacant at GHS Bandahu u/c GSSS Paplah, Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GSSS Kujji, Distt. Sirmour to GHS Bandahu u/c GSSS Paplah, Distt. Kangra, against vacancy, without TTA/JT as per his request.

Therefore, the representation of the petitioner is disposed of after due consideration.

Whereas, Sandeep Kumar, TGT (NM) presently working in GMS Luchhadhar u/c GSSS Pangna, Distt. Mandi has filed CWP. No. 17689/2025- titled as Sandeep Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Luchhadhar u/c GSSS Pangna, Distt. Mandi to one of the stations of his choice in Distt. Mandi The case of the petitioner was listed before the Hon'ble High Court on 14.11.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Since petitioner on account of his having undergone surgery of kidney stones is finding it difficult to stay at the present place of posting, he has filed representation to the competent authority for his transfer. Once Transfer Policy, formulated by the Government of Himachal Pradesh, enables an employee to seek transfer on medical grounds, this Court sees no impediment inasmuch as issuing directions to respondents to consider and decide the pending representation of the petitioner expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of observations made hereinabove as well as Transfer Policy, formulated by the Government of Himachal Pradesh. Pending application(s), if any, also stands disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 09.12.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Luchhadhar u/c GSSS Pangna, Distt. Mandi to GHS Dugrain u/c GSSS Hatgarh, Distt. Mandi against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Luchhadhar u/c GSSS Pangna, Distt. Mandi since 06.10.2022. Though the said teacher has completed his normal tenure at GMS Luchhadhar but at present vacancy is available in the GHS Dugrain u/c GSSS Hatgarh, Distt. Mandi where petitioner requested for transfer. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

"Office Order"

CWP No. 10087/2025 titled as Naresh Kumar V/s State of H.P. (Regarding grant to the petitioner the benefit of higher stage of pay of Rs. 41600/- from the date the petitioner have completed two years regular on analogy of Inder Singh Thakur.)

That the petitioners have filed the present Civil Writ Petition thereby seeking the relief to the extent that a writ of mandamus or any other direction may kindly be issued to the respondents to grant to the benefit of higher stage of pay of Rs. 41600/- from the date petitioner has completed two years of regular services in terms of the judgment passed by the Hon'ble High Court in CWP NO. 4830/2023 titled as Inder Singh Thakur & Ors. V/s State of H.P. and further respondents directed that the petitioner be re-fixed from the date petitioner have completed two years of their respective regular services and to release all consequential benefit alongwith arrear at the rate of 9% per annum.

The said case was listed before the Hon'ble High Court of H.P. on 26.06.2025 when the following orders were passed:-

"Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation dated 11.05.2025 (Annexure P-4) of the petitioner expeditiously, preferably within a period of eight weeks in light of Inder Singh case (supra). Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon. Liberty is reserved to the petitioner to file appropriate proceedings in appropriate court of law, if he still remains aggrieved. Pending applications, if any, also stand disposed of."

WHEREAS, as per information received from concerned DDSE, the petitioner was initially appointed TGT's on contract basis in the year 17.08.2012, and their service have been reqularised in the year, 31.05.2017. Whereas, the petitioners were appointed as TGT on contract basis in the pay scale of 10300-34800+3600 followed by the regular appointement to the post of TGT. The said petitioners filed CWP 10087/2025 before the Hon'ble High Court of H.P. to seek the benefit of higher grade pay after two years of their regular services on the analogy of Inder Singh Thakur. The detail particular of the petitioner is as under:-

Accordingly, in compliance of HP civil Service Category/ Post wise Revised Pay rules, 2012, the revised pay band + grade pay of 10300-34800+GP 5000 were granted to the petitioner on completion of two years of regular services. Hence, the petitioner is not entitled for the revised pay from the (Revised pay) 1st amendment Rules, 2022 notification on 06.09.2022. Accordingly, after considering the fact on record in particular the fact that petitioners have already availed the Grade pay in pre-revised scale. Hence, the representation of the petitioner is considered and disposed of accordingly.
