ORDER

In the matter of: CWP. No. 7981/2025-titled as Sh. Baldev Singh, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Baldev Singh, Headmaster, who is presently working in GHS Nayagan, Distt. Chamba has filed CWP No. 7981/2025- titled as Baldev Singh, Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Nayagan, Distt. Chamba (Hard area) to nearby his native place in Distt Kangra after completion of normal tenure. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 15-05-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"5. "Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents/competent authority to consider and decide his representation (Annexure P-3 and P-5) expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while giving personal hearing to the petitioner, may also take note of stations, which may have fallen vacant after filing of the representation, Pending applications, if any, also stand disposed of."

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 23-07-2025. The petitioner has attended personal hearing on 23.07.2025 and requested that he may kindly be transferred from GHS Nayagan, Distt. Chamba, H.P.(Hard Area) to soft area at GHS Mumta, Distt. Kangra, against vacancy, GHS Chambi,GHS Mehnja, GHS Malan, Distt. Kangra, against vacancy being caused due to promotion.

On the perusal of the record, it is found that the petitioner is working in GHS Nayagan, Distt. Chamba since 15-10-2022 which is a Hard area and he has completed his normal tenure at his present place of posting. The enrollment of students in class 6th to 10th at GHS Nayagan stands at Zero. He has given five stations of his choice in District Kangra in which one post of Headmaster is being caused vacant due to promotion of present incumbent in GHS Chambi, Distt. Kangra. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred from GHS Nayagan, Distt. Chamba to GHS Chambi, Distt. Kangra, against vacancy being caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

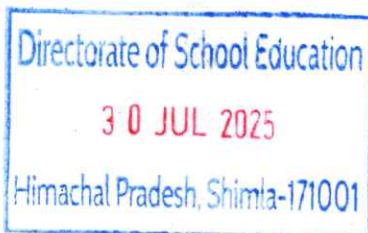

Whereas, Sh. Praveen Kumar Bhardwaj, DPE/ Lect. Phy. Education preferred CWP No.10998/2025 titled as Praveen Kumar Bhardwaj Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GSSS Habban, Distt. Sirmour to nearby his native place in Distt. Sirmour, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 02-06-2025 when the Hon'ble High Court has passed the following orders:-

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 28-07-2025. He attended the personal hearing on 28-07-2025. He attended the same and submitted his representation in this office on 28-07-2025, vide which he has requested that requested that he is on verge of retirement on 30-06-2027 and his parents are oldage and suffering from many health p̄omlems. So, he may be transferred from GSSS Habban, Distt. Sirmour to nearby his native place in Distt. Sirmour, against vacancy/longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Habban, Distt. Sirmour, H.P since 20-01-2023 and has almost completed his normal tenure at his present place of posting. The petitioner is going to be retire on 30-06-2027. At present the post of DPE/ Lect. Phy Education is lying vacant at GSSS Panar, Distt. Sirmour, H.P. The petitioner has given willingness for his transfer to the aforesaid school against vacancy. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby transferred to GSSS Habban, Distt. Sirmour to GSSS Panar, Distt. Sirmour, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordngl
