ORDER

Whereas, the petitioner namely Sh.Dharambir Singh Patiyal Lect.(History) is working at GSSS Guler (Kgr) w.e.f 15.03.2024 and having short stay and he has filed CWP No. 12996/2025 titled as Dharambir Singh Patiyal vs State of HP. This petition was listed on 13.08.2025 when the same was finally disposed with the directions to respondents as under:-

In such circumstances, the impugned order rejecting petitioner's representation for transfer from Government Senior Secondary School Guler, District Kangra does not warrant any interference. It is the discretion of the employer to post/transfer the employee in the State keeping in view its administrative exigency;

5. In view of above the present petition fails and is dismissed. Pending miscellaneous application(s), if any, shall also stand disposed of

And whereas, as per direction passed by Hon'ble High Court as above, the applicant was called to appear in this office for personal hearing on 03.09.2025 and was present on this date. During the course of hearing no request for any relief was made by the petitioner.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the petitioner i.e Sh.Dharambir Singh Patiyal Lect.(History) as per para 12.1 of "Comprehensive Guiding Principals-2013" the transfer of the Government employees, it is clearly mentioned that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/ transfer any employee anywhere in the state keeping in view of the administrative exigencies/ convenience. The petitioner Sh. Dharambir Singh Patiyal Lect.(History)will continue at GSSS Guler (Kgr). Hence representation stands disposed of.

May inform the parties accordingly.
