ORDER

In the matter of: CWP No. 16160/2025- titled as Duni Chand Vs. State of H.P. and others.

Whereas, Duni Chand, TGT (NM) presently working in GMS Kandhidhar u/c GSSS Murah, Distt. Mandi has filed CWP. No. 16160/2025- titled as Duni Chand, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Kandhidhar u/c GSSS Murah, Distt. Mandi to one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 14.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 29.09.2025 (Annexure P-1) in accordance with law and applicable transfer policy, within a period of three weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 23.12.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Kandhidhar u/c GSSS Murah, Distt. Mandi to GMS Alathu u/c GSSS Pari or GMS Shadhla u/c GSSS Katindhi or GSSS (B) Bhangrotu or GSSS (G) Bhangrotu, Distt. Mandi against longer stye or against vacancy on medical ground.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Kandhidhar u/c GSSS Murah, Distt. Mandi since 21.09.2022. At present, one post of TGT (NM) is lying vacant at GMS Shadhla u/c GSSS Katindhi, Distt. Mandi.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Kandhidhar u/c GSSS Murah, Distt. Mandi to GMS Shadhla u/c GSSS Katindhi, Distt. Mandi against vacancy without TTA/JT on medical ground.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
