ORDER

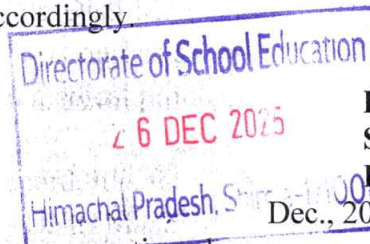
In the matter of:- CWP No. 19384/2025-titled as Promila Devi, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 19384 of 2025 in the Hon'ble High Court vide which sought her transfer from GHS Bag Chawasi u/c GSSS Mahog Distt. Mandi HP to soft area. The present CWP was listed before the Hon'ble High Court of H.P. on 08.12.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 22-12-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Smt. Promila Devi, TGT (Arts), submitted fresh representation and stated that she is working at GHS Bag Chawasi u/c GSSS Mahog Distt. Mandi and requested for transfer/adjustment either to GSSS Bhambla, GSSS Gehra, GMS Bah u/c GSSS Rakhota, GSSS Chandesh, GHS Pingla Distt Mandi or GSSS Chamboh Distt Hamirpur on account of completion of normal tenure as well as on her adverse family circumstances and the fact that her new born child is suffering from serious medical problems.

From the perusal of the record, it is found that Smt. Promila Devi, TGT (Arts), is posted at GHS Bag Chawasi u/c GSSS Mahog Distt. Mandi since 05.03.2022, she has completed her normal tenure at present place of posting. At present one post of TGT (Arts) is lying vacant at GHS Pingla Distt Mandi wherein about 35 students are enrolled, which also falls within the choice station of the petitioner.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Smt. Promila Devi, TGT (Arts) posted at GHS Bag Chawasi u/c GSSS Mahog Distt. Mandi is hereby transferred/adjusted at GHS Pingla Distt Mandi against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
