## **ORDER**

In the matter of:

CWP No. 7976/2025-titled as Sudhir Kumar V/s State of Himachal Pradesh.

Sh. Sudhir Kumar, TGT (Arts) is under order of transfer from GSSS Salaon Distt. Bilaspur to GMS Selli u/c GSSS Bani Materni (Solan) vice Sh. Anjna Kumari, TGT (Arts). Feeling aggrieved Sh. Sudhir Kumar, TGT (Arts) has preferred present CWP No. 7976/2025 in the Hon'ble High Court against his transfer. The same was disposed of on 15.5.2025. The operative portion of the Judgment is as under:-

"Having regard to the aforesaid submissions and without interfering with the transfer of respondent No.4 under the impugned office order to the place of the petitioner, this writ petition is disposed of by directing the Director of Education, Himachal Pradesh/competent authority to consider and decide the aforesaid representation of the petitioner dated 06.05.2025 (Annexure P-3) in accordance with law and applicable transfer policy within a period of one week from today. The decision so arrived at shall also be communicated to the petitioner.

Till such time, the petitioner shall not be compelled to join at the transferred station and shall be at liberty to avail leave of the kind due. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 7976/2025-titled as Sudhir Kumar, TGT (Arts) V/s State of H.P. on 15-05-2025, the petitioner was called for personal hearing on 24-06-2025 and appeared before the undersigned on scheduled date. During the course of hearing the petitioner has requesting that he may be retained at GSSS Salaon Distt. Bilaspur or adjust nearby his home as he is due for retirement less than two years.

From the perusal of record, it is found that Sh. Sudhir Kumar, TGT (Arts) transfer order was issued from GSSS Salaon Distt. Bilaspur to GMS Selli u/c GSSS Bani Materni (Solan) by clubbing his previous placed of posting vice Sh. Anjna Kumari, TGT (Arts). The petitioner (Sh. Sudhir Kumar) retirement is due within a period of less than two years. At present post of TGT (Arts) are not lying vacant in district Bilaspur.

Keeping in view of above narrated facts, the representation of the petitioner dated 24.6.2025 is considered and examined sympathically. Since the petitioner has left less than two years to retire and as per transfer policy Para No.5 sub para 5.5 the request of the petitioner be considered and the transfer order issued vide this Directorate letter dated 01.5.2025 at Sr. No. 23 and 24 is/are hereby withdrawn/cancelled. The representation of the petitioner with the present CWP is disposed of accordingly.
