Whereas, Smt. Manju Devi, TGT (NM) preferred Ex. Pet. No. .... /2024 in CWP No. 11837/2024 titled as Manju Devi, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Khunachi, Tehsil Thunag, Distt. Mandi, H.P. to nearby home station in Distt. Hamirpur/Una, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 23-10-2024, when the Hon'ble High Court has passed the following orders:-

3. "This writ petition is accordingly disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure P-3, shall be decided by the Competent Authority, sympathetically, in light of the averments made therein within a period of six weeks from today, by passing a speaking order, in accordance with law, and if possible, the petitioner be posted at a station of her choice. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted her representation in this office on 30-01-2025, vide which she has requested that she may be transfer from GSSS Khunachi, Tehsil Thunag, Distt. Mandi, H.P. to nearby station at her native place in Distt. Hamirpur/ Una, H.P, against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms., being a couple case.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Khunachi, Distt. Mandi, H.P. since, 02-03-2022 and has completed two winters and three summers at her present place of posting which is a tribal /difficult area in Distt. Mandi, H.P. One Sh. Rajan Ranout, TGT(NM) is working in GSSS Takoli, Distt. Una, H.P. since 28-04-2022. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and She is hereby transferred without TTA/JT from GSSS Khunachi, Tehsil Thunag, Distt. Mandi to GSSS Takoli, Distt. Una, H.P. vice Sh. Rajan Ranout, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Rajan Ranout, TGT(NM). The representation of the petitioner is disposed of accordingly.
