## **ORDER**

In the matter of:

CWP No. 7971/2025-titled as Yashwant Singh V/s State of Himachal Pradesh.

Sh. Yashwant Singh, TGT (Arts) is under order of transfer from GSSS Sandhole Distt Mandi to GSSS Kuthar Distt. Shimla. Feeling aggrieved Sh. Yashwant Singh, TGT (Arts) has preferred present CWP No. 7971/2025 in the Hon'ble High Court against his transfer. The same was disposed of on 15.5.2025. The operative portion of the Judgment is as under:-

"...However, having taken note of the fact that petitioner is left with one year one month service, coupled with the fact that transfer policy formulated by Government of Himachal Pradesh, enables an employee nearing retirement to seek transfer/adjustment at a station of his choice, this Court deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority within a period of one week, praying therein for cancellation of his transfer order/adjustment at nearby station, which in turn, shall be decided by the competent authority within a period of one week. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order thereupon, taking note of the transfer policy. Till the time representation, if any, filed by the petitioner within a period of one week is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station."

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 7971/2025-titled as Yashwant Singh, TGT (Arts) V/s State of H.P., the petitioner was called for personal hearing on 26-06-2025 and appeared before the undersigned on scheduled date. During the course of hearing the petitioner has requesting that he may be retained at GSSS Sandhole Distt Mandi as he is on the verge of retirement.

From the perusal of record, it is found that Sh. Yashwant Singh, TGT (Arts) transfer brder was issued on dated 09.05.2025 from GSSS Sandhole Distt Mandi to GSSS Kuthar Distt. Shimla vice Parmil Kumar, TGT (Arts) and petitioner (Sh. Yashwant Singh) retirement is due within a period of less than two years as his DOB is 08.06.1968.

Keeping in view of above narrated facts, the representation of the petitioner is considered and examined sympathically. Since the petitioner has left less than two years to retire and as per transfer policy Para No.5 sub para 5.5 the request of the petitioner be considered and the transfer order issued vide this Directorate letter dated 09.5.2025 at Sr. No. 03 and 04 is/are hereby withdrawn/cancelled. The representation of the petitioner with the present CWP is disposed of accordingly.

ORDER

In the matter of:-

CWP No11211/2025-titled as Rakesh Chand, TGT (Arts) V/s. State of HP.

The petitioner Sh. Rakesh Chand, TGT (Arts) transfer order was issued on dated 03.06.2025 from GSSS Kharwar Distt Hamirpur to GHS Mahipur u/c GSSS Bechar Ka Bagh Distt. Sirmour. Feeling aggrieved, he has filed present case in the Hon'ble High Court of HP and sought his adjustment. The case was listed before the Hon'ble High Court of H.P. on 11.07.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

".....the petitioner would be satisfied in case respondent No. 2/competent authority is directed to consider and decide the aforesaid representation within a time bound schedule. Learned Additional Advocate General is not averse to this prayer. In view of the above, this writ petition is disposed of with direction to respondent No. 2/competent authority to consider and decide the aforesaid representation of the petitioner dated 02.07.2025 (Annexure P-2) in accordance with law and applicable transfer policy, within a period of two weeks from today. The decision so arrived at shall also be communicated to the petitioner."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 18.7.2025 and appeared before the undersigned on the scheduled date. The petitioner (Sh. Rakesh Chand, TGT (Arts) has requested adjustment either at GMS Jatt Beli u/c GSSS Thakurdwara (Kangra)/GSSS Kinnu (Una)/GSSS Mandli (Una), citing that he has completed normal tenure of posting & his wife is also working as LT in Education department.

From the perusal of record, it is found that Sh. Rakesh Chand, TGT (Arts) has been posted at from GSSS Kharwar Distt Hamirpur w.e.f. 15.9.2022 and serving within the radius of 30 Kms. The transfer order of Sh. Rakesh Chand, TGT (Arts) from GSSS Kharwar Distt Hamirpur to GHS Mahipur u/c GSSS Bachar Ka-Bagh Distt. Sirmour, by clubbing his previous place of posting/tenure. It is important to highlight that the student enrollment at GHS Mahipur stands at 92, and the institution is classified as a soft area within District Shimla. Furthermore, Sh. Rakesh Chand, TGT (Arts) has not previously served in a hard or tribal area. The Hon'ble High Court's judgment in CWP No. 2734/2024, titled Monika Katna Vs. State of HP, upheld the legality and validity of the office memorandum dated 27.10.2023, which provides for the clubbing of stay for transfer purposes. The Court clarified that such clubbing is not contrary to Clause-10 of the Transfer Policy of the State Government. Additionally, in CWP No. 10255/2025, titled Bharti Rathour Vs. State of HP, the Hon'ble High Court emphasized that all departments must ensure that each employee is assigned to a sub-cadre or tribal area at least once during their service career.

In view of above narrated facts and as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Therefore, being a State cadre Government employee, the request of the petitioner is not tenable and hereby rejected. The representation of the petitioner with the present CWP is disposed of accordingly.
