**ORDER**

Smt. Ekta Thakur, JBT had filed CWP No. 11861/2025 titled Ekta Thakur Vs State of H. P. in the Hon'ble High Court of H.P. which has been disposed of on 24.07.2025. The operative part of the order is as under:-

“Consequently , in view of the above , this court, without going into the merits of the case with the direction to the respondents/competent authority to decide the pending representation having been filed by the expeditiously, preferably, within three weeks. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note thereupon taking note of transfer policy, which enables an employee to seek transfer from hard area to soft area after completion of normal tenure of posting at one place ie. Two winters and three summers. Pending applications, if any , also stand disposed of”.

In compliance of the orders of the Hon'ble High Court of H.P. and as per representation(Annexure P-1) the petitioner Smt. Ekta Thakur JBT was called to appear in person on 11.08.2025. The petitioner appeared on the scheduled date and time before the undersigned. The petitioner has also made a request to the undersigned stating that she may be transferred under clause 5.4 concession to couple case working under H.P. Government. Apart from this she has requested to transfer her due to her adverse family circumstances and pregnancy. Moreover, GPS Shalagad, Education Block Seraj-11 falls under the category “E” most difficult area .At the time of hearing, the petitioner has requested that she may be transferred from GPS Shalagad, Education Block Seraj-11 to EB Drang-1 against vacancy and EB Sadar-1 against vacancy and further requested that GPS Burna, Education Block Seraj-11 which currently has two teachers may be deputed to GPS Shalagad.

In order to adjudicate the case, the comments were sought from the Deputy Director of Elementary Education Mandi. Upon careful examination of the comments received, it is observed that the petitioner is working at GPS Shalagad, EB Seraj-11 District Mandi since 14.02.2023 and has completed 2 years 6 months stay at her present place of posting. It has further been brought to notice that GPS Thanera, EB Sadar-1 is a without Teacher school and one teacher has already proposed from de-notified/merged school against JBT post and one teacher may be adjusted against the HT post.

In view of above, and after due consideration of the petitioner's representation dated 26.07.2025 & 11.08.2025, the Deputy Director of Elementary Education Mandi is directed that the petitioner Smt. Ekta Thakur, JBT may be adjusted at GPS Thanera, EB Sadar-1 against HT post and Sh. Dalip Singh JBT may be adjusted at GPS Shlagad, EB Seraj-II, District Mandi vice Smt. Ekta Thakur JBT against the vacant post on larger enrolment basis being single teacher school. The representation stands decided accordingly.
