ORDER

In the matter of: CWP. No. 11401/2025-titled as Sh. Rakesh Chand, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Rakesh Chand, Headmaster, who is presently working in GHS Galeha, Distt. Shimla, H.P has filed CWP No. 11401/2025- titled as Rakesh Chand Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Galeha, Distt. Shimla to nearby his native place in Distt Hamirpur, H.P against vacancy. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 16-07-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

*"4. Consequently, in view of fair stand adopted by learned Additional Advocate General, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation (Annexure P-1) of the petitioner, expeditiously, preferably, within a period of ten days, taking note of Clause 5.5 of the Transfer Policy. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon and petitioner at the time of personal hearing, may also point out or bring to the notice of the Department any station, where he can be posted/adjusted. Pending applications, if any, also stand disposed of."*

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 11.08.2025. He attended the same and submitted his representation in this office on 11.08.2025, vide which he has requested that he is on verge of retirement on 31-01-2027 and his parents are old age and suffering from many health problems. So, he may be transferred from GHS Galeha, Distt. Shimla, H.P. to nearby his native place in Distt. Hamirpur, against vacancy.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Galeha, Distt. Shimla, H.P. since 19-11-2022 and has almost completed his normal tenure at his present place of posting. The petitioner is going to be retire on 31-01-2027. At present the post of Headmaster is lying vacant at GHS Phagoti, Distt. Hamirpur, H.P. The petitioner has given willingness for his transfer to the aforesaid school against vacancy. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby transferred from GHS Galeha, Distt. Shimla, H.P. to GHS Phagoti, Distt. Hamirpur, H.P, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.

Whereas, Sh. Surinder Kumar, DPE/ Lect. Phy. Education preferred CWP No.11475/2025 titled as Surinder Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GSSS Nishu, Distt. Mandi, H.P to nearby his native place in Distt. Chamba, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 17-07-2025 when the Hon'ble High Court has passed the following orders:-

*4. Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representation dated 06.07.2025 (Annexure P-1), of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of medical grounds, as detailed in page 19 of the paper book pending miscellaneous application(s), if any, also stand disposed of"*

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 11-08-2025. He attended the same and submitted his representation in this office on 11-08-2025, vide which he has requested that he may be transferred from GSSS Nishu, Distt. Mandi, H.P. to nearby his native place in Distt. Chamba, H.P, against vacancy/longer stayee on medical grounds.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Nishu, Distt. Mandi, H.P since 15-09-2021 and has completed his normal tenure at his present place of posting. The petitioner is suffering from psychiatric problem. At present the post of DPE/ Lect. Phy Education is lying vacant at GSSS Bondedi, Distt. Chamba, H.P. The petitioner has given willingness for his transfer to the aforesaid school against vacancy. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby transferred from GSSS Nishu, Distt. Mandi, H.P. to GSSS Bondedi, Distt. Chamba, H.P. against vacancy, without TTA/JT on medical grounds. The representation of the petitioner is disposed of accordingly.
