In continuation to this office letter of even no. of dated 08.11.2024, 19.11.2024, 07.12.2024 and 01.01.2025 vide which you were directed to provide the proforma for promotion in reservation of persons with Benchmark Disabilities (PwBDs) in the services of the State Government, for inclusion of names in the TGT promotion panel amongst TET pass in-service JBTs for the promotion to TGT (Med./NM/Arts) and in-service C&Vs for the promotion to TGT(Arts/NM/Med.) as per Govt. letter No:-4/1/2021(47)-SOM-Wel-RPwD-I-16690-750 dated 1st Oct. 2024 to this Directorate of Elementary Education on or before 10.01.2025.

In this context, as per direction/ instructions dated 10.01.2025 till date not a single fresh medical certificate (PwD Certificate) has been received which is necessary before proceeding further as per directions of Govt. letter No.PER(AP)-C-F(4)-1/2021 dated 6th Jan, 2022.

All the in-service JBT/C&V teachers mentioned vide letter dated 10.01.2025 (Annexure I to Annexure-IV) are directed to provide the fresh medical certificate (PwD Certificate) on or before **24.01.2025** through Deputy Directors. Other than this, any teachers who are eligible as per Govt. letter No:-4/1/2021(47)-SOM-Wel-RPwD-I-16690-750 dated 1st Oct. 2024 can also apply through proper channel in specified application performa. If candidate fails to do so then his/her selection for the TGT (Arts/NM/Med.) shall stand withdrawn and his/her candidature will not be considered for promotion.

Therefore, you are once again directed that promotion cases of eligible candidates for persons with Benchmark Disabilities (PwBDs) must be sent in all respect to this Directorate through special messenger on or before 31.01.2025.


