ORDER

In the matter of:

CWP No. 9481/2025-titled as Sushil Kumar, TGT (Arts) V/s. State of Himachal Pradesh.

The petitioner has filed present CWP No. 9481/2025 titled as Sushil Kumar V/s State of H.P. in the Hon'ble High Court vide which sought his transfer from GMS Tapoon u/c GSSS Mangla Distt Chamba to one of the station of his choice/soft area as he is working since 24.12.2014(10 years) in hard/difficult area. The case was listed before the Hon'ble High Court of H.P. on 06.06.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-


"Since, it is not in dispute that petitioner has completed more than normal tenure of posting in tribal/hard area coupled with the fact that CGP-2013 provides for transfer of an employee, who has completed normal tenure of posting in hard/tribal area, to a station of his choice in soft area, present petition is disposed of with a direction to respondent No.2 to decide Annexure P-2, expeditiously, preferably within four weeks, from today.

Needless to say, authority concerned shall afford opportunity of hearing to the petitioner and thereafter pass a speaking order, taking note of provisions of Comprehensive Guiding Principles. Liberty is reserved to the petitioner to approach competent court of law, in case, he still remains aggrieved."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for personal hearing on 24.06.2025 and appeared before the undersigned on scheduled date. The petitioner has sought his transfer/adjustment either at GMS Chamroli u/c GSSS Chaned/GMS Parel u/c GSSS Udaipur/GMS Gholti u/c GSSS Sarol/GMS Sultannpur u/c GHS Paccatala/ GSSS Sarol Distt. Chamba as his mother is very old and suffering from various old ailments and his daughter is 03 years old and not having good health and under treatment.

From the perusal of record, it is found that Sh. Sushil Kumar, TGT (Arts) is working at GMS Tapoon u/c GSSS Mangla Distt Chamba (Tribal area) and he is working in hard/difficult area since 24.12.2014(for more than 10 years). At present post of TGT (Arts) are not lying vacant in ibid mentioned schools, however one Sh. Kamleshwer Singh, TGT (Arts) working at GMS Chamroli u/c GSSS Chaned Distt. Chamba who is working since 03.05.2019 and has completed his normal tenure at present place of posting.

Keeping in view the position stated above, representation of the petitioner i.e Sh. Sushil Kumar, TGT (Arts) is considered sympathetically and he is hereby adjusted from GMS Tapoon u/c GSSS Mangla Distt Chamba to GMS Chamroli u/c GSSS Chaned Distt. Chamba vice Sh. Kamleshwer Singh, TGT (Arts) who may further be transferred/adjusted at GMS Tapoon u/c GSSS Mangla Distt Chamba (with TTA/JT to Sh. Kamleshwer Singh, TGT (Arts)). Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
