Whereas, now the State Government has enacted the Himachal Pradesh Recruitment and Conditions of Service of Government Employees Act, 2024 which has come into force from 20.02.2025 vide notification No. Per(AP)-C-A(3)-6/2024 dated 19.02.2025.

Whereas, as per Section 6(2) of the HP Recruitment and Conditions of Service of Government Employee Act, 2024(Act. 23 of 2025), a person shall be entitled for the service benefits only from the date of regularization of his services. Further, the act idbid, provides that service benefits already extended to the persons for the service, other than regular service shall stand withdrawn and it stipulates that the service benefits available under various Central Civil Services Rules, as applicable in the State, the Himachal Pradesh Civil Services Rules, and other service benefits such as, seniority, increment, promotion, etc. shall be applicable only to the employees appointed on regular basis.

And whereas in view of provisions of the Act, 2024 the Government instructions dated 10.06.2024 with regard to counting of contractual services for grant of pensionary benefits under CSS(Pension) Rules, 1972 have become in-fructuous.

Now therefore, I have gone through the facts and circumstances of the case and in view of the provisions contained in the HP Recruitment and Conditions of Service of Government Employee Act, 2024(Act. 23 of 2025) the claim of the petitioners has been considered and rejected.

May inform the parties accordingly.

ORDER

In the matter of:-

CWP No. 10095/2025-titled as Jeet Singh, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court of HP and sought his transfer from GMS Swar u/c GSSS Lohardi Tehsil Multhan Distt. Kangra to a station of his choice. The case was listed before the Hon'ble High Court of H.P. on 24.06.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"...direction to the respondents to consider and decide the pending representation dated 01.06.2025 (Annexure P-3) of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of transfer policy framed by the Government of Himachal Pradesh, which certainly enables an employee, who has completed normal tenure of posting in hard/tribal area, to seek transfer to one of the station of his choice."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 26.7.2025 and appeared before the undersigned on the scheduled date. The petitioner (Sh. Jeet Singh, TGT (Arts) has requested for his transfer/adjustment either at GHS Panjala(Kangra), GHS Yora (MND, GMSSS(Girls) Joginder Nagar (MND), GMSSS (Boys) Joginder Nagar, GSSS Chauntra Distt Mandi citing that he is serving in GMS Swar i.e. Difficult area of Distt. Kangra since 21.01.2019 (06 years) and having adverse family circumstances.

From the perusal of record, it is found that Sh. Jeet Singh, TGT (Arts) has been working at from GMS Swar u/c GSSS Lohardi Tehsil Multhan Distt. Kangra since 21.01.2019 and completed his normal tenure at present place of posting. It is important to highlight that the student enrollment at GMS Swar stands at 29, and the institution is classified as a Difficult area within District Kangra. At present no post of TGT (Arts) is/are lying vacant in the petitioner choice of Schools, but one Sh. Jai Chand, TGT (A) is working at GMSSS(Girls) Joginder Nagar (MND) Since 02.11.2023 and having short stay but serving within the radius of 30 Kms.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically on medical grounds. Accordingly, Sh. Jeet Singh, TGT (Arts), posted at GMS Swar u/c GSSS Lohardi Distt. Kangra is hereby transferred/adjusted at GMSSS(Girls) Joginder Nagar (MND), vice Sh. Jai Chand, TGT (Arts) and vice versa basis by clubbing his previous posting stay with the radius of 30 kms. (with TTA/JT to Sh. Jai Chand, TGT(Arts). The representation of the petitioner in the present CWP stands disposed of accordingly.
