ii) All the DDSE/Game Incharge are directed to ensure that official deputed from your district as one Coach, one Manager in each game and one contingent incharge.

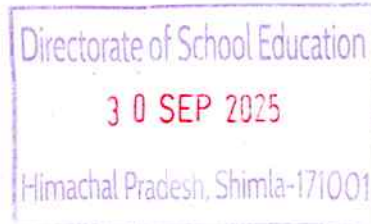
